## NOVEMBER MEMBERSHIP DRIVE

November has been selected as the 2002 Membership Drive Month. In preparation for the Membership Drive, eleven District Level Membership Meetings were conducted throughout Washington in October.

To acknowledge the effort of the councils during the November Membership Drive, a special one-time membership award will be presented to the leading councils in each of the five divisions with the highest net gain, the council with the highest net gain in the state, and the district with the highest net gain. The special membership award is a 10-inch by 13-inch specially framed replica of the *Holy Family painting* with a brass plate acknowledging the achievement of the council and the grand knight. It will be presented at the Regional Meetings. The district award will be presented at the District Deputies' Winter Meeting on December 7.

The councils and districts should plan major membership activities throughout the month of November. These activities should include:

- Host a council Open House,
- Contact the pastor to conduct parish membership drives including pulpit announcements,
- Request a parish roster and mail invitations to all male parishioners.
- Set-up membership table after Mass,
- Contact all eligible candidates,
- Contact all former members and all inactive insured members,
- Invite prospective members to your council's Thanksgiving or other social,
- Focus on the 18-year-old youth of the parish and former Squires,
- Schedule first degrees with the pastor as the honoree of the degrees,
- Immediately following the degree mail the form 100s to Supreme to insure they are recorded in November,
- Place as the council's major goal to recruit at least one member and become *membership active*,
- Plus other creative membership activities.
- Remember that reactivating inactive insurance members qualifies councils for both membership and insurance additions toward Father McGivney and Founder's Awards quotas.
- Remember that, reinstatements, readmissions or reapplications qualify councils for membership additions for the Father McGivney Award.



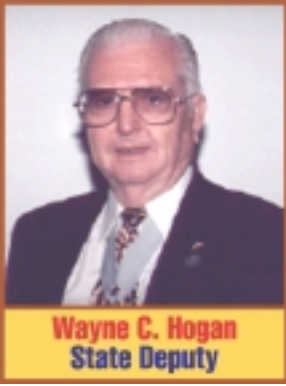
District Deputies should insure that all parishes without a council have a membership recruitment drive and schedule district wide first degrees.

The councils should promote the state's membership incentive, "With 15,000 you get \$1,500.00!"

- If the Washington State Council achieves membership of 15,000 by the end of the fraternal year 2002-2003, we will have a \$1,500.00 Give-Away.
- All former members and new knights who become knights during the 2002-2003 fraternal year (July 1, 2002 to June 30, 2003) will be eligible for the random drawing for the symbolic 15,000<sup>th</sup> knight.
- To conduct the drawing, Washington must achieve or surpass the membership status of 15,000 (gains, minus losses, minus transfers and deaths) by June 30, 2003.
- The Symbolic 15,000<sup>th</sup> and his sponsor must be in good standing at the time of the drawing.
- The names of all these knights will be placed in a container for the random drawing of the symbolic 15,000<sup>th</sup> knight and three lucky knights will be \$500.00 richer, the new knight, his sponsor and his Grand Knight.
- Remember, that all active knights are eligible to be sponsors.

### ANNUITY INSURANCE PROGRAM FOR OUR PRIESTS

During a recent discussion with David Hill, DD of District 1 and State Deputy Wayne Hogan, David shared his concern about the weak retirement program for our priests. He made a good point asking, "What do we do for our priests when they retire?" It's an interesting thought. We may have them over for dinner. But what other support do we Knights offer? Usually it is not much. Most priests, after working and supporting Catholics in our parishes for many years, end their careers with a limited retirement fund.

The Knights of Columbus wear badges on their jackets with the slogan "We Support Our Priests and Bishops." The question of how, when and where we do this comes to mind. It's obvious that our parish priest does get our support during his ministry and even before his ordination. Each seminarian in the State of Washington received support from our Councils this past year. Our Parish Priest has only to ask and the Knights are there to serve in any way they can, with their time, money and talent. But what about retirement, what can we do?

Some Councils have taken it upon themselves to start an Annuity Insurance Plan for their priests who are Knights. The plan can be started with \$300.00 then added to by the Council to supplement the

Archdiocesan Retirement Plan. Remember, an Annuity makes a Knight an insured member.

There are many ways to build this plan. Some Councils have an annual parish wide fund-raiser with all the proceeds going into the Annuity Plan for their priest. This way all parish members are involved, not just the Council members. Other Councils periodically add to the Annuity from Council funds.

As a priest transfers from parish to parish his Annuity stays with him, and his new Council then can pick up supporting the Annuity. You can imagine a priest with an Annuity transferring to a parish without a Council. I'm sure he would be delighted to have one formed.

If we are true to our promise to "Support Our Priests", the time to sit down with Council Officers and the Insurance Agent to build a plan and present it to the Council members is now.

Offering an Annuity to Father on Christmas morning would be a great present and better received than all the cookies, candies and cakes he will receive.

Let us truly live out our commitment to support priests in all areas of their ministry, from the seminary to retirement.

## WASHINGTON STATE MARCH FOR LIFE

The 25<sup>th</sup> Annual March For Life will be held in Olympia at noon on Thursday, January 16, 2003. The theme for this year's March For Life is: "Affirm the Sanctity of Each Human Life by Word and Deed." The marcher for life will gather on the Capitol Campus to witness that all life is sacred from conception to natural death.

In 1970, the people of the State of Washington passed Referendum 20. Thus, Washington State is the *only* State that has passed abortion on demand by a vote of the people. We come to remember the 30<sup>th</sup> anniversary of Roe v. Wade - the Supreme Court January 22, 1973, decision that decriminalized abortion which has ushered an era of death.

Last year, the knights were present in Olympia and supported the March For Life. Olympia Council 1643 provided a shuttle service for the marchers from St. Michael's to the Capital Campus and a hot lunch for the marchers after the March. Most Reverend William Skylstad, Bishop of Spokane marched and said the opening prayer. State Deputy Wayne Hogan also marched and led the Pledge of Allegiance. For the 2003 March For Life, Most Reverend Carlos A. Sevilla, SJ, Bishop of Yakima, has accepted an invitation to attend the March of Life and say the opening prayer. State Deputy Wayne Hogan has again been asked and accepted to lead the marchers in the Pledge of Allegiance. As the marchers recite the Pledge of Allegiance, the words 'Under God' will have a significant meaning this year because of the actions of the Ninth Circuit Court. We will profess to all that life is a special gift from God and that *life is sacred*.

Councils are encouraged to start planning to actively be a part of the 25<sup>th</sup> Annual March for Life. The councils should begin coordinating with their pastor and parish council. They should schedule buses for the knights, their families, and the parishioners. Councils are requested

to bring their Council banner to proudly proclaim to all that the Knights of Columbus are Pro-Life. Knights are encouraged to wear their council jackets, vests, and/or hats signifying their council name. They should start making Pro-Life signs. Please inform the State Pro-Life Chairman, Jay Quinn if your council will be marching for life and the number of marchers from your council and parish.

All knights and family members are encouraged to carry a red rose. Arrange to visit your legislators before or after the March. Encourage and thank those who are pro-life. Students will deliver live red roses to the Governor and Legislators on behalf of the pro-lifers in our state. A red rose is the symbol of the pre-born victims of abortion.

McEntee, President, March For Life, Washington State at 253-564-1497. March For Life is run by volunteers. Money is needed to cover costs of the actual event and year round related activities. There are many issues that confront us every day. Usually, we can see both sides of the issue and many times reach a compromise position, going from either an only black or an only white position to an acceptable gray position. *But the Pro-Life issue is either life or death, where is the compromise?* We knights pride ourselves in standing for principles, standing for those most in need, standing for our Order, standing for the Ten Commandments, and standing for our Church. Will you stand with us in Olympia on January 16, 2003? If not you, who? If not now, when?

## BIRTHRIGHT

Earlier this year *Birthright* of Seattle celebrated the 12th year of service to mothers and their children by completing some rather dramatic changes. They have increased the awareness of *Birthright's* existence in the community by advertising in local papers as well as increased use of yellow page directories.

They also made extensive changes in their physical environment, creating a facility more like a home than an office. An increase in the number of volunteers has permitted longer hours of local phone answering. Phones are answered 24 hours a day by using a national 800 number originally established by Supreme.

These changes require money according to Carl Anderson, Sr., Chairman of the Board of Directors at *Birthright* of Seattle.

An activity for support of *Birthright* would qualify for entry for the Herbert Liebert Award. Providing details about the activity, such as number of Council members involved would be advisable. Contact Brother Knight Carl at 425-822-8524 for more information.

**LESSON LEARNED**


All Form 4's submitted by Assemblies will be accompanied by an individual check (preferable) from the candidate. Assemblies should not write a check to the Master for one or more candidates. This causes problems when a candidate doesn't show. Case in point. An assembly wrote a check for 3 candidates, two didn't show. This happened over 2 years ago and they have asked for reimbursement. Which is not a major problem however, the problem is that the original check was deposited under the old Master and no records are available. If a separate personal check is submitted for each candidate, it can be returned immediately to that candidate along with the Form 4.

#### Recruitment Tools??

A recent discussion led to a question on recruitment in the form of "How about a discussion on recruitment and why can't we discuss different recruiting techniques"? That is an excellent question and the response was, "There are so many good ideas out there, that it could get bogged down in a very lengthy discussion which may or may not be of interest to everyone". If we carry it one step further and ask, "What is the greatest recruitment tool we have", what would be your answer? It is very important that we look now at where we are, where we have to go and how do we get there! I would suggest that there are many aids available: The Surge with Service booklet, the new "Recipes for Recruiting Success" booklet (Form 9290), the Grand Knights Handbook prepared by the State Council, the bi-monthly Knightline with supplement program, the District Deputies monthly outline and many more.

Your council's history is chocked full of ideas for recruitment using

the monthly programs that your council performs. Getting back to the main question, the answer is, "A Knight of Columbus asking a simple question of a potential member" followed by "Are you a member of the Knights of Columbus?" This is the best recruitment tool the Knights of Columbus ever came up with. You are the example, the inspiration and the recruiter that makes the recruitment of potential members successful. So look no further than in the mirror and the next time you see someone you know or don't know at a function ask him that simple little question, "Are You A Member of the Knights of Columbus?"

In the back of the Recipes for Recruiting Success booklet there are several forms to fill out. How many Dad Knights have recruited their Sons since 1 July? How many Son Knights have recruited their Dads since 1 July? How many Knights have recruited a priest since 1 July? Fill out a form and mail it to Supreme.

#### QUESTION OF THE MONTH?

What is the function of a roundtable and why bother forming one?

I am going to quote for you from Report of Roundtable Coordinator Form 2629 1/02, first paragraph: Supreme Knight Carl Anderson states "We have nothing less that a moral obligation to offer every eligible Catholic man the opportunity and the privilege of membership in our Order." He also states, "We must have a Knights of Columbus presence in every parish". Therefore, councils serving more than one parish are urged to implement the Parish Round Table program in each of the parishes. Anyone needing a copy of this form, ask your District Deputy as I provided each one of them with copies of every parish and mission in the State of Washington. All you have to do is finish it by talking with your parish priest, appoint a coordinator and have it signed by the Grand Knight. Do you know that you need only one knight in a parish or mission to form a roundtable?
