Two hundred years ago, **Meriwether Lewis and William Clark** were charged by President Thomas Jefferson to explore the Louisiana Purchase and discover a route to the Pacific Ocean. In October 1805, they entered what is now Washington State, journeying down the Snake and Columbia Rivers to the Pacific Ocean. **The Corps of Discovery inspired this year’s anniversary pin and “Discover a Knight!” slogan.**

Cultivating Your Soil—By Fr. Wilmar O Zabala

Her name is Marvel. She calls herself Captain Marvel. No, she’s not a crime-fighting heroine. She’s an elderly parishioner whom I visit regularly. Her main hobby is gardening. She loves gardening. She has a beautiful garden. Hers would easily make the front cover of Better Homes and Gardens magazine. She fertilizes the soil. She waters the plants. She pulls out the weeds. She does many other things that sound foreign to my ears. The love and care she gives her garden is extraordinary. I sometimes wonder where she gets the energy to cultivate and maintain such a lovely garden. In one of my recent visits – I found her in her lovely garden, of course – I came to realize that “gardening” is a beautiful metaphor for God’s caring love for us.

I found out that “garden” comes from an Old English word that means enclosure. Its “root” word comes from the same English words that give us guard, gird, and ward – words that speak of defense and a careful watching pres-

ence. Defense. A careful watching presence. A garden then is a space that is protected and enclosed. Life can grow there because it is defended against injury and danger. A gardener is one who *conscientiously* watches over this sheltered patch of land. A gardener cares for it and cultivates it.

Imagine God as the gardener and our lives as the soil. Can God walk with slow, sure steps, as though his bare feet enjoy the cool damp soil? Is God delighted by this garden? Should we be ashamed to let God see our own rough patches? Is the soil empty of any growth? Does it only hold sharp rocks? Does it only grow clumps of weeds?

We should let the Divine Gardener cultivate it. Perhaps, we should even let this Divine Gardener enter our secret plot of weeds and rubbles. This Divine Gardener will create new rich bounty from the chaos of our lives. Divine seeds will germinate in our hearts, and we will not be able to wait to see what new life will spring forth in the seasons that come!

The Coat of Arms of His Excellency, The Most Reverend Carlos A. Sevilla, S.J., D.D., Bishop of Yakima

Blazon: Arms impaled, Dexter: Or, on a bend inverted Gules, between two tepees Sable, a sword of the field. Sinister: Per fess Or and Gules; in chief the monogram of the Holy Name above three nails of the second; in base displayed upon two hills of the first, the facade of the Mission Dolores, Argent and Sable; overall a fess Azure charged with a seme of mullets of six points each, of the first.

Significance: The episcopal heraldic achievement, or the bishop’s coat of arms, is composed of a shield, with its charges (symbols), a motto scroll and the external ornaments. The shield, which is the central and most important feature of any heraldic device, is described (blazoned) in 12th century terms, that are archaic to our modern language, and this description is done as if being given by the bearer with the shield being worn on the arm. Thus, it must be remembered, where it applies, that the terms dexter and sinister are reversed as the device is viewed from the front.

By heraldic tradition, the arms of the local bishop of a diocese are joined to the arms of his jurisdiction, in this case the Diocese of Yakima. These arms are composed of a gold (yellow) field on which are seen a red bar (known as a “bend”) that runs from the upper left to the lower right of the field. The edges of this bend are “inverted,” to give an illusion of water. On the bend is a gold (yellow) sword and on either side of the bend is a black tepee.

The inverted bend is used to signify the Columbia River that traverses that area that is now the Diocese of Yakima. On either side of this river are Native American tepees to honor the peoples that inhabited this region and whose languages gave rise to such things as the name of the See City of Yakima, which came from the Spokane Indian word, “Neeneeyakema” which was their word for neu-

trality, “we meet and part.” On the bend is the two-edged sword representing St. Paul, preacher of The Word and Apostle, titular of the Cathedral Church in Yakima.

For his personal arms, His Excellency, Bishop Sevilla has retained a modified rendering of the arms that were adopted at the time that he was selected to receive the fullness of Christ’s most holy priesthood when he was elected to be an Auxiliary Bishop of San Francisco.

Bishop Sevilla’s arms are composed of three sections. The upper portion, known as a “chief,” is gold (yellow). On this field are displayed three red nails and a red “IHS,” which is known as the “monogram of the Holy Name.” These symbols are the traditional insignia of the Jesuits, the Bishop’s religious family, The Society of Jesus. These charges are placed above a red field on which are seen two gold (yellow) hills, representing two volcanoes which are the dominant landmarks of the city of Colima, in Mexico, the native city of the Bishop’s parents, Jesus J. and Juana Cobian Sevilla. The two hills also represent the “Twin Peaks” of San Francisco seen from the façade of the Mission of San Francisco de Asis, popularly known as “Mission Dolores,” around which the City of San Francisco, in California, has developed since its origins in 1776. This church is near the neighborhoods where Bishop Sevilla lived as a boy and young man and, therefore, it has particular significance in the Bishop’s heritage as a San Franciscan.

Placed upon the Field of the Bishop’s biological heritage and his religious heritage is a blue bar across the middle that is charged with a scattering (seme) of gold (yellow) six pointed stars. This

Message from Vocations



Vocations support in Councils and Assemblies is at a very high level, and for that, I offer my thanks and appreciation. One thing, however, worries me - there are Councils in the Washington State Council that have neither a Pennies For Heaven drive nor are they participating in the RSVP program. The obvious question to these Councils is - what are you doing for a vocations program? What can I do to help you start one?

As of mid-June, there are more than 20 Councils that have not participated in the annual Pennies For Heaven drive. Some have historically participated, yet no funds have been turned in yet. There is still time to write a check - the PFH books don't close until July 31st.

We have met our annual goal for Pennies For Heaven, but it was a worrisome event for me. For the first time in my six years as Chairman, we closed out the convention short of our goal. Right now, the donations have reached nearly \$54,000, but if the remaining Councils that normally contribute follow up on this appeal, we could reach nearly \$60,000 for the fraternal year. RSVP support is up substantially from last year's \$80,000 and is expected to reach in the neighborhood of \$90,000 this year.

If your Council or Assembly wishes to sponsor a seminarian, please contact me directly.

I should be the only contact that you need to be assigned a seminarian to support through RSVP - it is my responsibility to see that EVERY seminarian is supported, and only then can I adjust the support level more equally.

Pro-Life Message

Respect Life and September 11, 2001



This month the Seattle area was blessed with a respect-life banquet sponsored by Pro-Life Washington, the Billboard People. The banquet was attended by many Knights too numerous to count, with State Deputy Pat Maloney and State Vice Chaplain Father Scott Connolly in attendance.

Monsignor Philip Reilly, founder and executive director of Helpers of Gods Precious Infants a nationally known respect-life priest, was the keynote speaker. At the end of Monsignor's talk, he gave his account of September 11, 2001 in New York City.

On September 11, Monsignor was praying the Rosary at an abortion center across the harbor from the World Trade Center when the attacks took place. The sky was covered with a huge black cloud, and the priest that was praying with the Monsignor, Fr. Delendeck got the call from the NY city fire department that he was needed at the Twin Towers to help. Msgr. Reilly said he would keep the vigil going at the abortion mill, and sure enough the abortion center continued operating. It was the only non-emergency business that was known to have kept on operating in NY on that day. The killing of children did not stop on September 11th.

After the attacks, the firemen understood exactly what the attack on the towers meant to them. They understood they were going to enter the towers and many were not coming back. At the twin towers they asked Father Delandeck for general absolution before going in. The firemen removed their helmets or hats, knelt down and father gave them general absolution. They then picked up their heavy equipment, went into the towers and ascended using the stairs because the elevators were broken. As the people were going down the stairs, they saw the faces of the fireman going up. The firemen reached the 80th floor as the towers came down, killing 350 firemen in less than 3 minutes.

As Monsignor indicated to us, the cry of life is moved by love. The firemen were moved by love to give their own life so that others may live.

Monsignor indicated to us that today's ground zero is at the abortion mills. Monsignor asked us to go to the ground zero's of today moved by love for the children and their mothers, as a witness to a peaceful, prayful, loving presence. The next day many knights and fourth degree color guards joined Monsignor and Father Egan at Mass at St. Ignatius Chapel at Seattle University and then processed 5 blocks to the abortion mill for a peaceful prayer vigil, reciting all 20 decades of the rosary. Following the prayer vigil, the KC's and their wives from council 676 hosted a lunch and a brief talk from the Monsignor about sidewalk counseling. If your pro-life chair or chaircouple would like more information, or to develop a similar program at your parish or council, please give us a call.

Message from the PFH Treasurer



The Pennies From Heaven (PFH) Fund is for charitable, religious and educational purposes that qualify as exempt organizations under section 501 (c) (3) of the internal revenue code, which means the PFH Fund goes to qualified organizations that promote and assist in the religious education of those individuals seeking to become a Catholic priest.

The management of the PFH Fund Corporation is through a Board of Directors which is made up of the duly elected Officers of the Washington State Council of the Knights of Columbus, the Immediate Past State Deputy and State Chaplain. The Corporation has Articles of Incorporation and Bylaws which govern the operation of the PFH Fund.

The PFH Fund has three investments accounts. The first is known as the Investment Account, the second is the PFH Savings Account and the third is the Christopher Fund Account. All three accounts are PFH Fund assets and supply the funds for the donations given to the Bishops in Washington State. This past year the three Bishops in the state of Washington each received \$20,000 from the PFH Fund. Since 1992-1993, over 1/2 million dollars has been donated to the Bishops for the religious education of new priests.

These three above accounts are maintained by the membership that donate to the PFH Fund, i.e. "365 Clubs;" "PFH Barrels" and "Council Donations."

At the council level we look at the "365 Club" as a penny a day and a prayer a day. To belong to the club a member donates \$3.65 per year. Some members give a lot more, like \$36.50. The State Council asks that each council meet a quota of \$3.65 X council membership.

The "PFH Barrel" is another way the members donate. It is not part of the 365 Club and is above and beyond the quota requested by the State Council. The PFH Barrel is not used for any other purpose, like donations for food, etc.

The "Council Donation" is usually any amount necessary to meet the council quota. Some councils exceed the quota by using a larger figure i.e. \$3,650 or the council number as a goal.

As written above there are three investment accounts, the first, the Investment Account, is controlled by the Board of Directors through a Money Manager which is an investment company. Most of the donations go into this account. The second account is the PFH Savings Account controlled by the Board of Directors and is used to pay expenses and donations to the Bishops. The third is the Christopher Fund Account, managed by the Supreme Directors. The Washington State Council invests \$5.00 per membership net net gain as of May 31st of each year in the Christopher Fund Account; Supreme matches this same amount and returns to the PFH Fund the interest from the Christopher Fund. The Washington State contribution is prescribed by Supreme and may change in the future.

The amount of donations from the membership; the compounded interest and dividends from the Investment Account; the interest from the Christopher Fund (which is over \$70,000 since 1995) and PFH Savings Account interest, minus expense, in most cases determines what amount will be donated to the three Bishops.

The important thing for council members to realize is that the purpose of the PFH Fund is to help the Bishops pay for the education of men studying for the Priesthood.

Up to this point I have said nothing about the Refund Support Vocations Program (RSVP). This program is operated by Supreme and has no connection to the PFH program which is operated by the Washington State Council. The funds from the RSVP go directly to the seminarians. Further information is in the Grand Knights Handbook, pages I-6 and II-20 through II-24.

My hope is that some light has been shed on the very important PFH Fund.

July 3—As we celebrate God’s gift of freedom in our land, it is good to recall the words of President Ronald Reagan: “Abraham Lincoln recognized that we could not survive as a free land when some men could decide that others were not fit to be free and should therefore be slaves. Likewise, we cannot survive as a free nation when some men decide that others are not fit to live and should be abandoned to abortion or infanticide.” *Abortion and the Conscience of a Nation*

July 10—During the chaos of the battle for Terri Schiavo’s right to life, some sane voices were heard. Cardinal Renato Martino, president of the Pontifical Council for Justice and Peace, spoke clearly of the principle involved, “I would like to remind everyone about all that the Holy Father said. . .confirming that the quality of life is not interpreted as economic success, beauty and physical pleasure, but consists in the supreme dignity of the creature made in the image and likeness of God.” *National Catholic Register, 3/6-3/21/05*

July 17—“The intrinsic value and personal dignity of every human being does not change depending on their circumstances,” Pope John Paul II taught. “Providing food and water to such patients should be a natural thing to do and ‘morally obligatory,’ but not considered extraordinary measures,” he said. “In particular, I want to emphasize that the administration of water and food. . .always represents a natural means of preservation of life, not a medical treatment. Removing the feeding tube of a disabled person is a serious violation of the Law of God.”

July 24—In all debates, understanding the definition of terms is critical. The debate over human cloning is a case in point. “Reproductive cloning is cloning with the intention of creating a child who will be born. Therapeutic cloning is cloning to use human embryos of their stem cells in experiments while never allowing them to grow into fully developed human babies. Thus, therapeutic cloning is cloning to kill, the creation of human lives in order to end them for the sake of others.” Population Research Institute, “Briefing on UN’s Step Forward on Human Cloning,” 2/25/05

July 31—During California’s debate over a bill to legalize assisted suicide, the California Catholic Conference pointed out that if suicide becomes legal, “the pressure to make that ‘choice’ will increase with the burden of illness, age or diminished economic status. Predictably and practically, the disabled, the elderly and the poor will not be fully welcome to partake in community resources when they have the ‘other’ option.” *The Southern Cross, Diocese of San Diego*

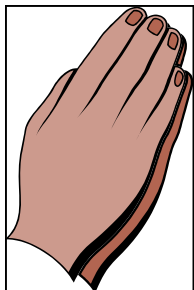
