Worthy Brother Knights:

The State Officers and Chairmen had the pleasure of meeting with everyone at the Regional Meetings and hearing about all the wonderful activities that are being conducted at the council level. We had the opportunity to discuss forming new councils and round tables, conducting the revised ceremonials, improving membership recruitment, promoting insurance for our members, preparing for the state convention, reviewing upcoming program activities, learning about the new Squires Advancement Program, and determining how to achieve the maximum number of Star Councils.

The degree teams from Richland 3307, Tukwila 11253, and Lynnwood 5816 put on great performances of the revised first degree in Yakima, Olympia, and Everett, respectively. These were excellent opportunities for other team members to witness the revised degrees. I'm sure the candidates were particularly impressed.

Aside from the degree competition, **the best parts of the meetings were the myriad of ideas shared by the attendees!** Those of you who did not attend the meetings missed a great deal of information (not to mention a few jokes).

I was privileged to represent you by leading the Pledge of Allegiance at the January 18, 2006, **Right to Life Rally at the Capitol in Olympia**. I was proud to see so many councils and brother Knights I'm sure we made an impression on the politicians. **A special thanks to the two new auxiliary bishops, Joseph Tyson and Eusebio Elizondo, for attending!**

As of January 31, 2006, we are now ahead of last year's net membership pace (292 vs 260), due primarily to fewer suspensions. However, **37 of 138 councils (27%) have not yet recorded any new members with Supreme.**

The **October Membership Blitz was extremely successful - begin now to plan for the March Blitz to ensure you will exceed the numbers from both 2003 and 2004 for Form 100s**



and **Prospect Cards!** In the meantime, please learn the revised first degree ceremony quickly and exemplify the **potential candidates** remaining from the October Blitz (**Only 60 members were exemplified in January!** **The more members we gain, the fewer of us will be "burned out" and the more activities we can conduct for our church and community.**)

Congratulations to councils 829, 2999, 3611, 6686, 8150, 8201, 8872, 9238, 9434, 9637, 10532, 10653, 11217, 11357, 11478, 11642, 12583, 13238, 13374, 13560, 13794, and 13834 for having already achieved 100% or more of their membership quotas and councils 829, 1620, 8455, 8476, 9434, 9721, 10653, 11134, 11217, 12591, 13560, 13606, 13794, and 13831 for achieving 100% or more of their insurance quotas!)

"Category I" Councils 829, 9434, 10653, 11217, 12560, and 13794 have met both quotas and should all achieve the coveted Star Council Award.

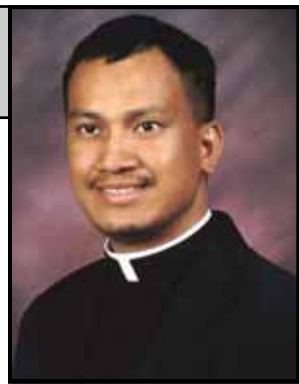
A Priest's Takes on Valentine's Day by Fr. Wilmar O Zabala

February is one of my favorite months of the year. I am very fond of calling this month my second Christmas because the giving and loving that mark Christmas become very visible once again. We see these gestures most specifically on Valentine's Day. Like Christmas, Valentine's Day quite often loses its meaning because of wrong emphasis. Valentine's Day is more than just buying your loved one a more meaningful present, taking him or her on a long-awaited date, and expressing your often-unsaid love for him or her. One can do any of these activities any day of the year. I don't claim to be an expert on relationship, but I couldn't help making these suggestions on having a wonderful, memorable Valentine's Day:

- Review your own relationship with your spouses, family members, friends, co-workers, and neighbors. Forgive those who have wronged you, and ask for forgiveness from those whom you have offended.
- Write a letter of gratitude to those who have shown you examples of genuine, unconditional, faithful, committed love.
- In addition to taking your spouse on that long-awaited date, repeat saying the words of your vows that you recited at your wedding day. Recalling what those are is itself an act of love for the other.
- If you're a widow or a widower, think of those times when your spouse embraced, steadied, humored, teased, and blessed you. Look at your wedding pictures.

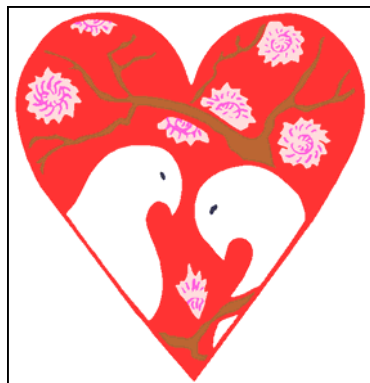

The History of Valentine's Day

One legend contends that Valentine was a priest who served during the third century in Rome. When Emperor Claudius II decided that single men made better soldiers than those with wives and families, he outlawed marriage for young men -- his crop of potential soldiers. Valentine, realizing the injustice of the decree, defied Claudius and continued to perform marriages for young lovers in secret. When Valentine's actions were discovered, Claudius ordered that he be put to death.

Other stories suggest that Valentine may have been killed for attempting to help Christians escape harsh Roman prisons where they were often beaten and tortured.

According to one legend, Valentine actually sent the first 'valentine' greeting himself. While in prison, it is believed that Valentine fell in love with a young girl -- who may have been his jailor's daughter -- who visited him during his confinement. Before his death, it is alleged that he wrote her a letter, which he signed 'From your Valentine,' an expression that is still in use today. Although the truth behind the Valentine legends is murky, the stories certainly emphasize his appeal as a sympathetic, heroic, and, most importantly, romantic figure. It's no surprise that by the Middle Ages, Valentine was one of the most popular saints in England and France.



Message from Membership Chairman



Wow. Every year after the regional meetings I feel like all of the state officers have finished running a marathon! Back to back meetings across the state for two weeks can get a little tiring. But there are a couple of important differences between this and a marathon.

First, we haven't reached the finish line yet! We're just over halfway there, and the good news is that we're really hitting our stride in membership growth. We've just about caught up with last year's pace and by following up with all of the prospective members we discovered in the fall Blitz, we can pull ahead and make it possible for more men to enjoy the Experience of a Lifetime.

The other big difference is that a marathon has one winner. But in this race, every participant can win and there are no losers. Winning in membership isn't about numbers, it's about a man finding a way to strengthen his faith through service and through having a peer group of Catholic men. It's about protecting a man's family through our fraternal benefits. It's about having an instant group of brothers and friends when a man moves to a new town. It's about a council having new hands to help with the annual parish cleanup, the monthly pancake breakfast, the Lenten soup supper or fish fry.

I was gratified during the regional meetings to have such great participation from Grand Knights across the state—not only by your presence, but especially by your attention and by sharing your ideas about what works for you in recruiting. During the Spokane regional meeting, District Deputy #20 Larry McKeever shared some great information with all of us about recruiting techniques that work. I want to share just a few of the ideas with you all.

First, BE VISIBLE. Encourage all of your council members to wear the emblem of the Order to Mass and to every parish service activity. Vests, aprons, polo shirts, and name badges are great ways to show your parishioners that the men they see doing God's work are Knights. They'll want to be Knights, too. And who knows—some youngster in the congregation might say, "Daddy, why don't YOU have a name badge?"

Next, BE CONFIDENT. Look a prospective candidate in the eye. You're proud and enthusiastic to be a Knight. Let it show! Enthusiasm is contagious, and confidence is important in getting a chance to show that enthusiasm. Strike up a conversation with the prospective candidate by asking about his family or how long he has been in the parish. After you've gotten to know each other a little you can ask him if he's ever been invited to join the Knights.

Finally, DON'T PRE-JUDGE A PROSPECT. Many times we make assumptions about a man because we know he is a busy executive, manager, or businessman and think he'll say he's too busy. Or perhaps he is an older man and we assume he's been asked to join before. Often you'll be surprised to find that a

busy man can find the time to be a productive Knight, or he'll be astute enough to realize that he can be a good Knight just by being counted as a member of the Order even if he can't come to meetings or help out at many council functions. And sometimes you'll find that an elderly man can discover the Experience of a Lifetime just as well as a younger man—and the experience and enthusiasm he brings to the council can be amazing.

One of the enjoyable aspects of the regional meetings was being able to present the winners of the incentive drawings for participants in the November Discover a Knight Blitz. The top Blitz council in each of the five size divisions, plus one randomly selected winner in each division, received a copy of the beautiful book *By Their Works*, personally inscribed by the State Deputy. The winners for Division I (<50 members) were Councils #9605 (best Blitz) and #13364 (random); Division II (50-99 members), Councils #9434 (best Blitz) and #1758 (random); Division III (100-149 members), Councils #2999 (best Blitz) and #829 (random); Division IV (150-249 members), Councils #2763 (best Blitz) and #1379 (random); and Division V (250+ members), Councils #5816 (best Blitz) and #676 (random).

Another treat was presenting the winners of last year's "Double Your Success" challenge (200% of quota by June 30, 2005) with a leather-bound book, "Faith and Fraternalism—The History of the Knights of Columbus 1882—1982" inscribed by Supreme Knight Carl Anderson. Councils receiving this prestigious award were 829, 2999, 3307, 7908, 8201, 8437, 8872, 9434, 9721, 11134, 11217, 12591, 13462, and 13374. Note that the PGK Augie Zampardo of Council 13951 passed away shortly after the end of the fraternal year and his widow, Margaret, will receive the book with the inscription to her recognizing Augie's leadership.

Finally, the Grand Knights and District Deputies that achieved 100% of their membership quota by December 31, 2005 were recognized. The leaders of the following councils and districts will be receiving a Knights of Columbus jacket for their excellent efforts thus far this year:

Councils: 829, 2999, 3611, 6686, 8150, 8872, 9238, 9434, 9637, 10532, 10653, 11217, 11357, 11478, 12583, 13238, 13560, 13591, 13606, and 13794

District Deputies: #1 (Dan Donohue), #10 (the late Wade Walden), #15 (Monte Cromwell), #18 (Donald Spragg), #20 (Larry McKeever), #25 (Fred Moritz), and #29 (Delbert Murray).

Another upcoming incentive award is the pursuit of the elusive Contest of Champions awards. A beautiful framed print of Pope Benedict XVI will be awarded to the councils achieving the top net gain and percentage of goal in the state. Smaller framed copies of the print will be awarded to the leaders in each of the five size divisions.

Message from Retention



My brother knights:
I enjoyed meeting with a lot of you on the West side at the meetings in Olympia and Everett. I sent the retention twelve step program, that DD # 2 initiated, to the East side meetings in Spokane and Yakima. I am sorry I couldn't attend in person.

The two most disturbing issues that arose out of the meetings on the West side were:

1. The fraternal year is half over and too many councils have not established a retention committee yet. Who should be on this committee? The GK, DGK, FS, membership chairman and proposers if possible.
2. Members from the retention committee must conduct exit interviews with members that the council knows are moving away, whenever possible. Find out where he is going, get a cell phone # or new address before they depart. Or at least give him a self-addressed envelope so he can mail you his new location. Alito confirmed by U.S. Senate

By a vote of 58-42, the United States Senate voted Tuesday morning, January 31, to confirm Samuel Alito as an associate justice of the U.S. Supreme Court. The Board of Directors of the Knights of Columbus unanimously endorsed his nomination at its regular meeting on January 15. Supreme Knight Carl Anderson wrote to senators in November, asking that they reject anti-Catholic prejudice in considering Alito's nomination. Despite a similar letter from State Deputy Karl Hadley and requests from many Washington State Knights of Columbus, our two senators, Murray and Cantwell, voted against the nomination.

Message from Recruitment Chairman

Then when you have a spare moment, take out your sheet of paper and look at your goal. Ask yourself, how many new members do I need each month to reach my yearly goal? Write down all the names of candidates and put a mark by each one that you feel is ready to join. Share this list with all the officers and ask their help in getting these candidates to fill out a form #100. Check with your officers each month and ask how

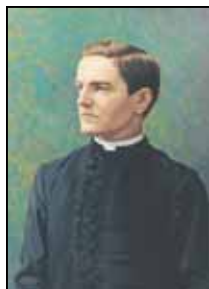
COUNCIL HISTORIES STILL NEEDED

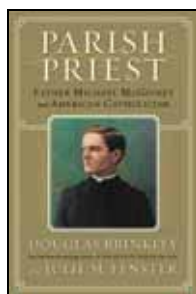

February 5—Commenting on embryonic stem cell research, the Pontifical Academy for Life astutely observed, “The attitude some adopt concerning the legitimacy of sacrificing human beings at the embryonic state...in order to benefit other human individuals, is totally unacceptable. It is never morally licit to do evil intentionally in order to achieve ends that are good in themselves.”

February 12—”Being pro-life is not a hobby. It is a vocation. It is, first of all, a basic aspect of our vocation to ve human, and a foundational element of our vocation as Christians. Everyone is called to live out this aspect of his or her vocation in one way or another.” Fr. Frank Pavone

February 19—Pope John Paul II made clear the Church’s teaching on providing food and fluids as normal care: “I should like particularly to underline how the administration of water and food, even when provided by artificial means, always represents a *natural means* of preserving life, not a *medical act*. Its use, furthermore, should be considered, in principle, *ordinary* and *proportionate*, and as such morally obligatory, insofar as and until it is seen to have attained its proper finality, which in the present case consists in providing nourishment to the patient and alleviation of his suffering.” (March 20, 2004 at International Congress of Life-Sustaining Treatments and vegetative State)

February 26—”For modern man, the idea of placing limits on research sounds like blasphemy. However, an intrinsic limit exists, and this is human dignity. Progress obtained at the price of the violation of human dignity is unacceptable. If research attacks man, it is a deviation of science.” Cardinal Joseph Ratzinger, now Pope Benedict XVI.
