## Message from State Deputy Karl Hadley "EVERY DAY A NEW KNIGHT"

Worthy Brother Knights:

With the start of a new year, it is customary to evaluate our state, district, and council status with respect to meeting our goals and to plot out the strategy for attaining those goals during the remainder of the year. Part of that task is to look back on the first six months of the fraternal year, but more importantly, it is the **time to look forward** and determine what remains to be done **to finish the year successfully**. What new activities and events have you planned to make your mark as the **best grand knight the council has ever had**? Have you drafted your **Columbian Award Application** and determined how many **activities** you need in each program area?



At the Summer Leadership Meeting in Wenatchee I **challenged you to recruit a record number of over 1056 new members** during the fraternal year. Historically, December is one of our best months for recruitment. However, this December, we brought in only 67 new members, bringing us to a total of **only 377 to date – we have fallen behind the rate of membership growth of the last two years!!!!** (Perhaps the power outage in Western Washington had an impact?

If so, let's achieve a record recruitment level in January!) That leaves us with 679 or 113 per month from here on out.

Are you on track to achieve the coveted Star Council Award? **Why not set your goals higher to achieve the "Double Star" Award?** (Congratulations to councils 829, 2999, 8150, 9434, 9637, 11134, 12899, and 13560 for achieving that level last year!!!)

As of December 31, 2006, over half of the councils are now membership active, but **43 of 140 councils (30.7%) have not recorded any new members with Supreme. (Congratulations to councils 829, 1401, 2999, 3044, 3611, 5177, 7117, 8872, 9145, 9238, 9434, 11642, 12175, 12591, 12786, 12983, 13606, and 14046 for having already achieved 100% or more of their membership quotas – 8872 already is at 200% and 12983 is at an amazing 300%!!!! - and councils 3611, 7528, 7908, 8102, 8137, 8201, 10653, 11357, 11762, and 14046 for achieving 100% or more of their insurance quotas – 14046 is at 200%!!!)**

Have you exemplified all candidates from the **October Blitz**? During the **October Membership Blitz, 338 Form 100s and Prospect Cards** were signed, but **only 149 new members were exemplified** in November and December – **what happened to those other 189 new members?** Please ensure their First Degrees are conducted in January, even if you have only one candidate! Don't let them go very long without receiving their exemplifications.

\*\*\*\*\*

Have you developed a **list of 20 potential candidates** that might help you to exceed your membership and insurance goals? Will you need to recruit even more members to **make up for any suspensions?** **Those 56 councils that did not participate in the October Blitz could conduct a membership drive in January and bring in another 240 new members!** Recruitment of new members results not only in council growth, but **prevents burn-out of recycled officers, brings in new ideas, and creates future leaders** with renewed purpose of what the Knights stand for. **Without council growth, our programs will not flourish and will be of interest to our membership.**

This year I also announced a new Retention Policy and I am pleased to report that **during the month of December we only lost 15 members, bringing us to cumulative loss of 103 suspensions to date – the lowest total in several years!!!** I thank you for your retention efforts! Even so, with the 103 suspensions to-date, we have room for only 167 for the remainder of the fraternal year, or only 28 per month. With the annual dues cycle approaching, please continue your excellent retention efforts! Even though we are behind our recruitment pace, the low level of suspensions leaves us at a **net gain of 274 – half-way to our goal of 549.** Not bad for the first six months! Not bad at all!

Have you adequately **trained your successor** to take over as grand knight once your term is completed? Does your council have a **succession plan for other new officers?** Have you scheduled first degree members for the **next 2<sup>nd</sup> and 3<sup>rd</sup> degree exemplifications** so that they can assume council offices?

While losses of members are inevitable, the best way to overcome them is to **"increase our intake"** of new members. To this end, even though blitzes are successful, our slogan should be **"Every Day, a New Knight!"**

If you're like most people, you're probably working on your New Year's resolutions right now. Perhaps, this coming New Year, you are resolving to "quit smoking or drinking," "to be more charitable and non-judgmental," "to spend less and save more," "to lose weight and exercise daily," "to be a more loving and caring spouse and parent," or, if you're like me, "to spend less time watching "Sportscenter" or "Survivor." I used to make New Year's resolutions every year, but I stop when I recognize that the biggest majority of my resolutions have gone by the wayside before January is over and that I don't remember most of them six months later! Actually, if you honestly ask me, the reason why I stop making New Year's resolution is because of my greater understanding and appreciation of Paschal Mystery

make time for prayer these days. That's not surprising if we have a day like this, as described by Ron Rolheiser in one of his beautiful articles: "We rise early, groan as our alarm clocks startle us from sleep, rush through breakfast, ready things for the day, fight some traffic enroute to work, settle into a task that's demanding and draining, gulp-down a quick lunch, end the work-day tired, commute back home, ready another meal, tend to the needs of loved ones, share a meal with others who are just as tired and restless as we are, and then, often enough, we still have another event to attend in the evening."

Yes, the day simply takes us, consumes us, drains us, and leaves us, in its wake, sitting on the couch before a TV set, tired, dissipated, and wanting a mindless distraction rather than, perhaps, the discipline of prayer or reading our scriptures. It's hard to make room for prayer in our over-busy lives, when so many necessary tasks demand our attention and when so much inside us aches for activity and involvement. Resolving to make more time for prayer will not only slow us down, but, most importantly, help us focus on Jesus as the center of our lives. And that's very helpful, especially when we, in our lives, end up suffering from the kind of headaches and heartaches that cannot be eased by taking an aspirin. Let's resolve to make more time for prayer this new year. It's a time well-spent.

– the crucifixion, death, and resurrection of the Lord. "Paschal Mystery" reminds me that my life is an experience of "dying" and "rising," that every single day is always a new day to change my wrongdoings, a resurrection, if you will, that allows me to rise from my mistakes or from whatever keeps me from being the kind of person God wants me to be. "Paschal Mystery" reminds me that I don't have to wait for the New Year to be a better person. Every single day is my chance!

### Message from Membership Chair



Merry Christmas and a Happy New Year! I hope you have all resolved to share the Experience of a Lifetime with every eligible Catholic man in your parish by inviting them to Support Our Parish Priests. Our growth in membership order-wide and throughout the state is impressive, but it barely scratches the surface of the number of Catholic families that deserve the opportunity to have the protection and security of our fraternal services, and the chance to participate in the good works and spiritual growth that a member of our order enjoys. Urge each member of your council to make a personal New Year's resolution to ask another Catholic man to join them in the Knights of Columbus.

As I anticipated in last month's bulletin article, membership throughout Washington State is starting to take off as the results of the Blitz take effect. More and more councils are achieving a significant early milestone-fulfilling 100% of their membership quota by December 31, 2006. These lucky Grand Knights are earning a Knights of Columbus jacket, and are well on their way to earning a signed commemorative book-personally endorsed by our Supreme Knight, Carl Anderson-for achieving 200% of their membership quota by the end of the fraternal year. Those Grand Knights and District Deputies earning jackets this month will have the opportunity to select the size, style and color of their jacket at the upcoming Winter Regional Meetings, January 6, 7, 13, and 14. I also look forward to visiting with all of you and sharing some ideas, some brotherhood, and a lot of important information. I pray that you'll all enjoy safe travels to the meetings and bring along your enthusiasm and energy.

The State Deputy just announced a new incentive program for the next two months' recruiting efforts. Remember the free dinner awards that were promised to Grand Knights who achieved four or more new recruits by August 30? We're going to do it again... a free dinner certificate for councils recruiting four or more members during January and February! By the way, in case I didn't announce it earlier, the winners of the August 30 dinners were Councils 3361, 4782, 9238, 12175, 12983, and 13831. Congratulations to these Grand Knights who will receive gift certificates for \$25 at the Regional Meetings this month.

We will be rolling out a few exciting new programs and incentives at the Regional meetings. First is the incentive award for achieving the goal of 16,000 members in the Washington State Council. It'll be a tight race to see if we achieve the goal this year, but we're on track to get there... our membership as of December 31 is 15866 members. If we do achieve this milestone by the end of the fraternal year, we will randomly select an honorary 16,000<sup>th</sup> member from among all the new members who joined us during the year. That lucky member, as well as his proposer, will each receive a framed portrait of our founder, Fr. Michael J. McGivney, as well as a copy of his biography, *Parish Priest*, inscribed by the State Deputy. In addition, the Washington State Council will make a donation to Pennies for Heaven in the amount of 16,000 pennies (\$160), credited to the

16,000<sup>th</sup> member's home council. I'm excited by this incentive because it symbolizes our founder's vision of a growing, vital organization serving our parishes and priests, and matches up with our recruitment theme for this year.

The second new program that we'll share at the Regional Meetings is a new award modeled after the highly successful Shining Armor program. Many Knights have asked whether there's a chance of expanding the Shining Armor program to include those brothers who did not have the opportunity to earn the Shining Armor award during their first year of membership. As a reminder, Shining Armor requires a member to attend three business meetings, support three council activities/functions, meet with their fraternal benefits agent, take their second and third degrees, and recruit at least one new member... all during the first year after they join the Order. The great part of the program is that it gets new members active in the council, while also helping increase membership by bringing in another new member.

We considered simply expanding the eligibility of the Shining Armor program, but decided that we don't want to detract from the prestige associated with this program. Instead, we have borrowed an idea from another state council and are instituting the Silver Knight award. The Silver Knight will be awarded to members who attend three business meetings, support three council functions, maintain 2<sup>nd</sup>/3<sup>rd</sup> degree membership in good standing, meet with their fraternal benefits agent or maintain insurance membership status, and recruit at least two new members, all during any year of membership. The member fills out a qualification card and the Grand Knight and Financial Secretary attest to meeting the conditions as they are achieved, and when complete the Grand Knight sends the completed qualification card to the State Secretary. The State Council will then provide a beautiful pin and a certificate to the Grand Knight for presentation to the member.

## Messages from General Program Director



Worthy Brother Knights:

Happy New Year to you and your families. We have entered into the second half of the 2006-2007 fraternal year. Where does your council stand?

Each month, I publish the top five councils in the state as of the previous month's reporting period.

This report is not in the order of standing, just the top five. Some councils have yet to submit a service program report for this fraternal year, some councils are missing a few, and several councils have submitted all their reports. The top five councils as of December 31<sup>st</sup> are: **St. John Henry Newman Council 11252, Woodland; Holy Spirit Council 10653, Kennewick; St. Louise Overlake Council 4385, Bellevue; St. Michael's Council 12786, Kelso-Castle Rock; and Fr. Justin P. Garvey Council 6686, Bothell.** Congratulations to these five councils.

Each month the Grand Knight has certain responsibilities to fulfill and January is not an exception. This month each council in the state must submit an "ANNUAL SURVEY OF FRATERNAL ACTIVITY" FORM 1728 to the Supreme Council to be received by Supreme no later than January 31, 2007. On a final note, I apologize to the membership for my article being missing in the last issue of the state bulletin. For some unexplained reason when I sent it to the editor it did not arrive.

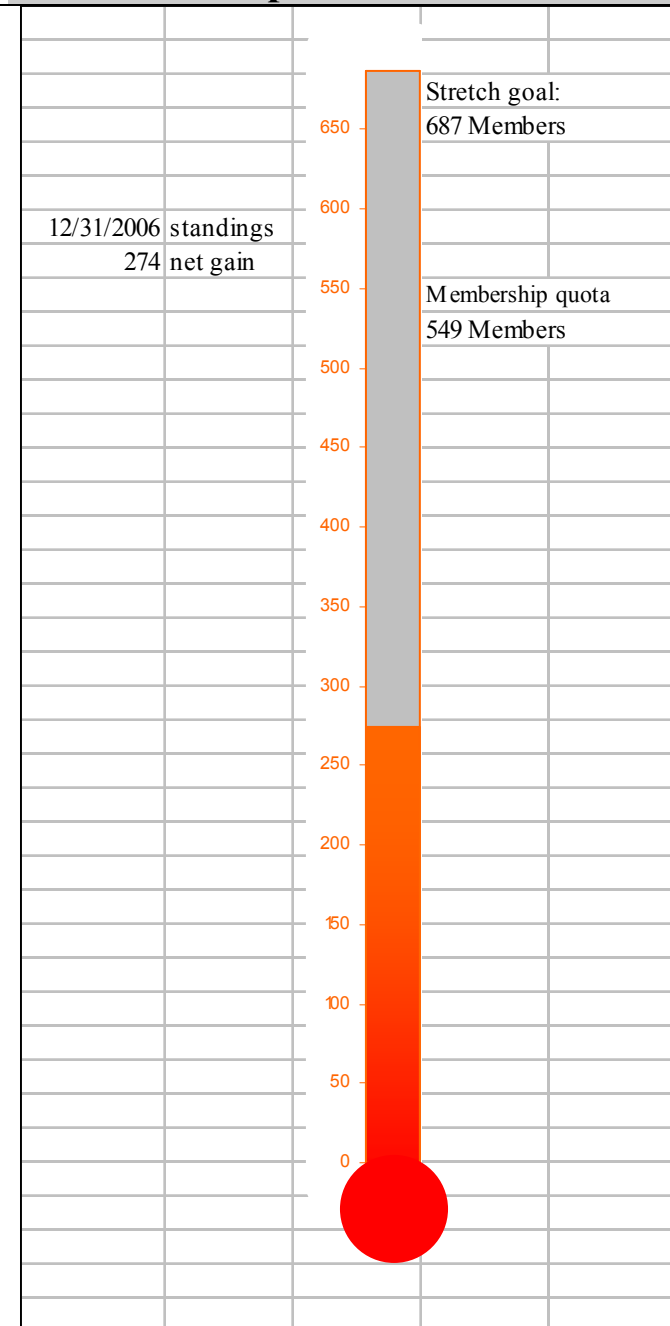

Our fine vocations program began in 1958; the first year's contributions amounted to \$58 and change. At that time, the price of a loaf of bread or a quart of milk was about 19 cents.

We all know what has happened to the price of a loaf of bread and a quart of milk.

The year 2007 is our 50th annual collection; however, a goal of just over \$54,000 - a penny a day - just is not realistic in these times. Just to keep pace with the original goal, adjusted for inflation over the past half century, we would be collecting \$260,000 per year for the Pennies for Heaven program. To double our goal, in the value of 1958 dollars, would require today more than half a million dollars given annually to the program.

The annual letter and goals sheet is being distributed to Grand Knights, Financial Secretaries, and District Deputies. Please send in your contribution as soon as you can; I would request a minimum of checks be brought to the annual convention in May.

## Veterans Administration Volunteer Service (VAVS)

Worthy Grand Knights and Faithful Navigators:

Happy New Year to all and as Fr. Lee said at midnight mass at 10:00 PM, wish everyone Emmanuel.

I want to thank those Knights who donated to the VAVS Christmas Canteen Fund and it was warmly appreciated by the service members who received the canteen books at the Lakewood Veterans Center. I only wish that we could have done more but next year, I will try to remind everyone earlier about the programs throughout the state.

In keeping with my December message, I want to invite you as Knights and Sir Knights to get actively involved in the VAVS program. I will try to give you some insight into not only some of the programs but ways in which you can help from volunteering in many different ways at the hospital or other veterans area to how to just donate goods or other services to the men and women who so desperately need your help and services. I also want to recognize some of the Knights of Columbus members and families who donate their time behind the scenes. I want to inform you of some information put out by the VA that will give you an overview of what a volunteer may be expected to understand.

**Customer Service and Service Recovery** are interrelated concepts that can be translated into practice; applications that reinforce the confidence, trust, respect and loyalty that our veteran patients have for VA Health care. VA volunteers are an integral and significant force in ensuring that the VA meet and exceed those expectations our veterans have for the service the VA provides and that when the VA do not meet those expectation, they do their "best to make it right" for that veteran or their family member.

### Veterans Expectations

The men and women who have served America honorably in our armed forces have earned the right to expect the best possible service from our employees and volunteers when it comes to their health care needs. As volunteers, you are in a unique position to ensure that our veterans are treated with C.A.R.E. (Care, Affection, Respect, and Enthusiasm) and that we do all we can to make sure that our veterans continue to come to the VA for their



care and improved quality of life.

### Customer Service

Customer Service as it is defined for the Voluntary Service Program is any activity or interaction that enhances the veterans experiences and exceeds their expectations. 2

### Service Recovery

Service Recovery is defined as the practice of retaining our customers' loyalty and respect when we have not performed as well as we could have and have not met our customers basic expectations.

### What can you do?

There are many ways that volunteers working through the Voluntary Service program at their local medical center or community based clinic (CBOC) can get involved in customer service and service recovery projects, activities or programs. The following examples are just some of the ways that volunteers and community organizations are making sure that receiving outstanding service and that when we sometimes "mess up", that we do everything we can to correct the situation and make that veteran or family member satisfied.

Next month some ideas on the Guest Services Program, Greets/Ambassadors/VIP Programs, Nursing/Patient representative or Patient Advocate Liaison, Reading/Coffee/Beverage Cart and Service Recovery Ideas.

Also, now that the season of Emmanuel is over and all those wonderful new clothes have been received or maybe some clothes you have outgrown, what to do with those trousers, shirts, dresses or other items that are taking up valuable closet space. **Jan 7**—The debate over using embryonic stem cells for research rages on with many people still ignorant of the fact that adult and umbilical cord stem cells are already treating an impressive list of over 70 diseases and injuries. It is therefore incorrect to “advertise” embryonic stem cell research as the “only way” to help the afflicted and it is unfair to label those opposed to research that kills tiny human beings as cruel and uncaring. **Jan 14**—A prospective 16 year old abortion patient, after viewing a free sonogram of her unborn child, testified in her own words regarding the power of a picture: “As soon as I seen that, I was ready. It wasn’t no joke. It was real. It was like, he’s not born to the world yet, but he is inside of me growing.” *Washington Post*, 9/10/06

**Jan 21**—January 22, 2007 marks the 34th “birthday” of the Supreme Court’s abortion-approving decision, *Roe v. Wade*, a ruling that has denied a birthday to millions of American children. Who can comprehend the height and depth of the devastation this single legal decision has brought to men, women, children, communities, and society at large?

**Jan 28**—One of the legacies of legalized abortion is the increasing number of abortions of children deemed not “perfect” enough to live. The President’s Council on Bioethics recently stated that prenatal testing produces “toxic knowledge” because it so often leads directly to abortion. (*LifeNews.com*, 9/11/06) According to the Genetics and Public Policy Center, screening of embryos from *in vitro* fertilization procedures in 186 clinics resulted in 66% of couples choosing to screen out (i.e. kill) embryos feared to have chromosomal abnormalities, 9% for the sake of sex selection, and 1% to get a match for a sibling in need of a transplant. In these clinics, 21% of them were “unaware” of having made errors in diagnosis. (*The Washington Post*, 9/21/06

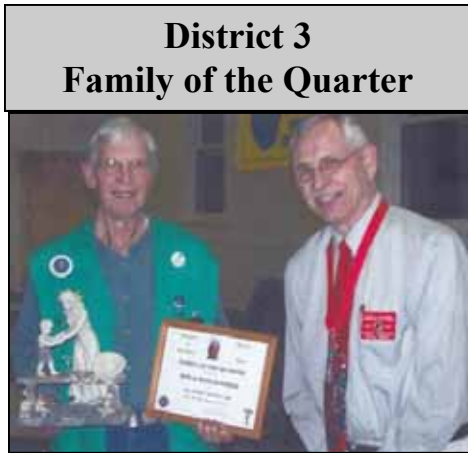

## URGENT MESSAGE from Historian



The Washington State Council will publish an addendum to the state history in May 2007. When the original history was printed in 1990, there were 90 councils and 22 assemblies in Washington. Since then 50 councils and 16 assemblies have been instituted. We have also survived a supreme director, 8 state deputies, a vice-supreme master and 6 masters.
