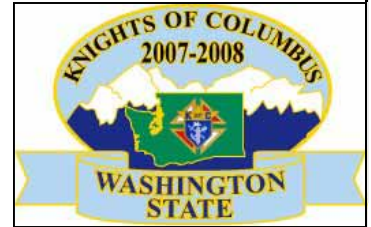

## Schedule for WSC Regional Meetings

## Message from State Deputy John Walker “Where We Are—Progress Report”

As we begin the second half of the fraternal year, “Where Are We” in terms of meeting our goals for the first six months and where do we go from here to meet the remaining goals and finish the fraternal year on a successful note. What new activities and events have you planned to make your mark as the best Grand Knight your Council has ever had?? Have you drafted your Columbian Award Application and determined how many activities you need in each program area?



Are you on track to achieve the coveted Star Council Award or better yet the “Double Star” Award for reaching 200% of your goal? Congratulations to Councils 829-Bellingham, 3611-Anacortes, 4385-Belleuve, 8015-Arlington, 8872-Colbert, 9145-Cheney, 9434-Mill Creek, 11642-Mercer Island, 11784-Brenerton, and 12983-Vancouver for achieving 200% or more last year.

Have you exemplified all your candidates from the October Blitz?? If not, why not? Don’t let them go very long without receiving their 1<sup>st</sup> degree lest they think you are not interested in having them join the Order. Always remember that recruitment of new members results not only in growth of your Council, but prevents burnout of recycled officers, brings in new ideas, and creates future leaders with renewed purpose of what the Knights stand for. Without Council growth, your Councils and the Order will not flourish.

It is not too early to start training your successor to take over as Grand Knight once your term is completed. Do you have a succession plan for other new officers? Make sure you schedule 1<sup>st</sup> Degree members for the next 2<sup>nd</sup> and 3<sup>rd</sup> Degree so that they can assume council offices.

The State membership goal was to recruit 1000 new members during the fraternal year. In the past December has been one of the best months for recruiting. However, we brought in 66 new members (compared to 67 last year), bringing us to a total of only 362 to date (compared to 377 last year)— we have fallen behind the rate of membership growth of the past two years!!! We need a record recruitment level in January. We need a total of 638 or 106 new members for the next six

months to reach the 1000 mark. Can we do it? With your dedication and work, I think so.

We have over half of the councils in the State membership active. Thirty eight (38) of 142 Councils (26.7%) have not recorded any new members with Supreme. The goal was for every Council to be membership active, even if it is only one new member. Councils inactive are noted elsewhere in the bulletin. Congratulations to the following Councils for having already achieved 100% or more of their membership quotas: 2260-Port Angeles, 7642-Kirkland, 8137-Spokane, 8150-Kent, 9910-Monroe, 10653-Kennewick, 11217-Seattle, 11357-Langley, 11408-Kirkland, 12583-Spokane, 12983-Vancouver, 13238-Tacoma, 13560-Granite Falls, 14162-Fife, and 14268-Newport. Vancouver 12983 leads all with 260%. Congratulations to the following for achieving 100% or more of their Insurance membership quotas: 2260-Port Angeles, 2103 Grandview, 11357-Langley, 11642-Mercer Island, 11780-Covington, 11948-Puyallup, and 12983-Vancouver.

Port Angeles 2260, Langley 11357 and Vancouver 12983 have already achieved Star Council Award. Special congratulations to them.

We are falling behind in our net gain of 569 set by Supreme. During the month of December we had 41 suspensions bringing the cumulative loss to date at 137 (34 more that last year at this time). I thank you for your retention efforts! With the annual dues cycle approaching, please continue your excellent retention efforts! We are behind in our recruitment efforts and ahead of our suspensions which leaves us at a net gain of 225 – far less that half-way to Supremes goal of 569.

While losses of members are inevitable, the best way to overcome them is to recruit new members to off-set the suspensions and then recruit a few more to achieve your Council goal. It can happen through the next Blitz and by adopting the slogan – “Every Day, a New Knight!”

As we get to the end of the year, we read many articles in the paper about the year's best and worst in politics, sports, and movies. What I am going to do here isn't like one of those articles. You have had enough of them anyway. But I thought it would be nice to write about the best things that happened to me this past year. Consider it my delayed Christmas letter to you without the photos of happy people in matching sweaters, without the report about spouse, children, home, or dog! By the way, I said that I have only the best to share. For one thing, there were no unfortunate and tragic events that happened to me. I continually thank the Lord for it. Also, I look at events in my life through the lens of faith, so what may be a tragedy for some isn't that way to me. Of course, I am a joyful person, too, because I have Jesus in my life. Christian life is

a life of joy. Sure, I still have things to worry about, and sometimes I encounter many unexpected things that burden me. But I have a strong enough faith and trust in Jesus that he will help me take care of them. I don't have to – and I don't want to – spend my time worrying about them and being miserable to the people around me in the process. Christian life is a life of joy. If you really think about it, there's so much to be joyful about. Without any further ado, here are the best things that happened to me this wonderful year of 2007:

**The Travels for Weddings:**

I hear that my brother priests don't like witnessing marriages. I don't understand why, but I love witnessing marriages, especially when the couples fly you to places like Waikiki or Philadelphia and pay for all your personal expenses! Most couples who ask me to witness their marriages already know me in the parish. I say that I'm honored to be asked. I don't personally ask why they want to be the priest presiding at their wedding ceremonies, but they always make those known to me: that I show in my actions and words that I enjoy what I do in the ministry, that I bring joy to the liturgy, that I am very funny. I don't know about the last one, but I'll take it as a compliment! These couples

want to let their mostly Protestant friends know that our Catholic services are reverent, joyful, and inspiring. These couples believe that I am the right priest to do it. Thus, I begin to see these travels for weddings as a way not only to get non-practicing Catholics excited about their faith once again, but, most importantly, to let non-Catholics see and know that we Catholics are on fire for Jesus as well.

**The Ministry to the Young and Text Messaging:**

It's sad that many high school and college age students are still uncomfortable in the presence of a priest. They have this stereotype that priests are out of this world, unapproachable, grumpy, boring. I try to change that, and I'm not quite sure yet if I have been successful. But perhaps these two experiences would help you help me decide. A college student from our parish going to school at WSU (Go Cougars!) invited me out to lunch when she was home for the Thanksgiving break. It was nice visiting with her. I am glad to know that she's very active in the campus ministry. You don't hear anymore about a college student inviting a priest out to lunch these days! Another college student who goes to school at Gonzaga (Go Bulldogs!) came home to visit her family in Richland. It was the eve of the Feast of the Immaculate Conception of Mary. At 11:30 PM that night, I received a text message from her, asking me what time the Masses would be the following day. There's something beautiful about a college student sending a text message to priest at 11:30 PM asking for the Mass times! I didn't care if it woke up in the middle of my sleep! Those Jesuits over there in Spokane are teaching those kids well, I tell you! Yes, she was there at Mass that morning. Your being an approachable priest comes a long way in the ministry – and, of course, knowing how to respond to text messages, too!

Oops, I am running out of room. I guess you'll just have to wait until next month to read about the other ones. I hope I won't forget what I was going to write. Have a great New Year!

### Initiative Would Legalize Physician-Assisted Suicide

A proposed initiative to legalize physician-assisted suicide for terminally ill patients is expected to gather signatures next year. (Starting after filing on January 4, 2008). The initiative would need approximately 300,000 signatures by July, 2008 to be validated for next November's election.

Catholic teaching condemns physician- assisted suicide, said the United States Conference of Catholic Bishops, "because it, like murder, involves taking an innocent human life."

Our State Chaplain, Most Rev. Carlos A. Sevilla, S.J. has indicated "the passage of this initiative could ultimately result in a form of state sanctioned euthanasia that would diminish respect for human life." He further states: "I ask that the Knights of Columbus in our state actively participate in defeating this initiative through educating people in the parishes and contributing financially to the campaign. There is a need for significant funding to defeat the initiative. Adding the Knights' voice to the clear and consistent call to defeat the initiative will be vital to respecting the dignity of life."

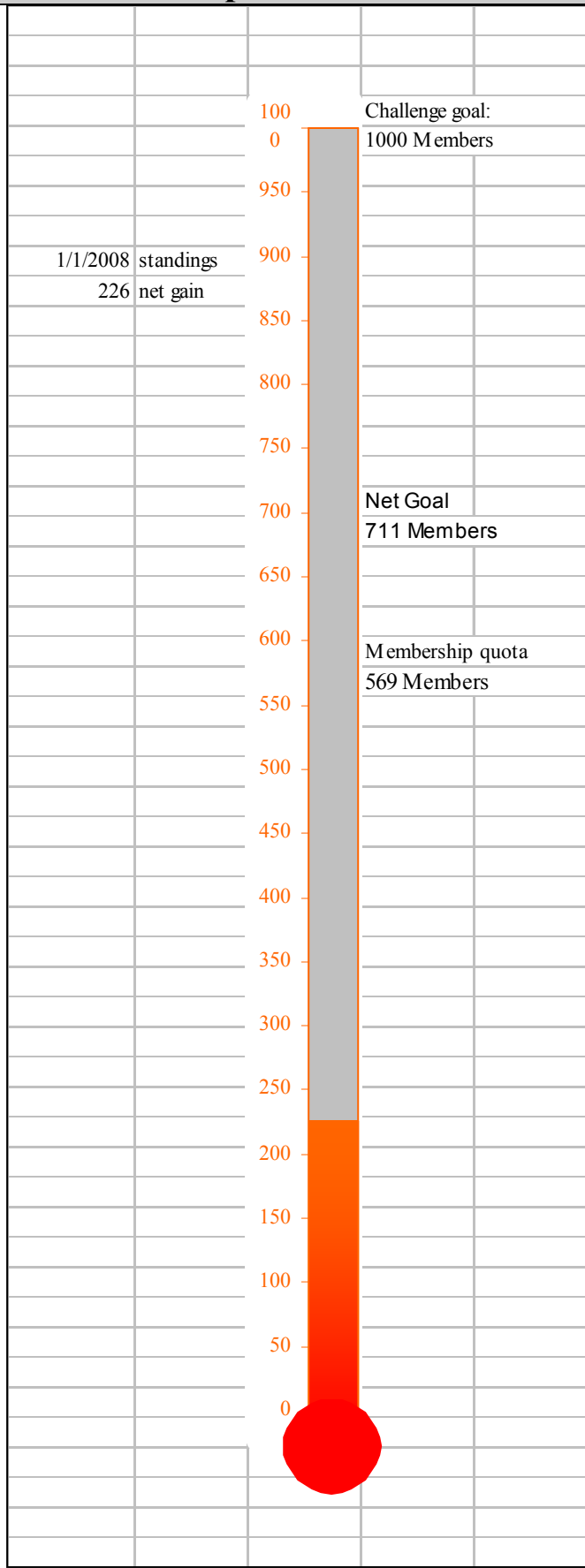

## Knights of Columbus insurance set three new records in 2007 Insurance in force tops \$66 billion; monthly, yearly sales are best ever

New Haven, CT - January 2, 2008 - Knights of Columbus life insurance in force reached \$66.1 billion at the end of 2007, setting a new all-time record, Supreme Knight and Chief Executive Officer Carl A. Anderson announced today. It was the seventh consecutive year of insurance sales growth for the Order.

"The year 2007 was a very strong year for us," Anderson said. "Not only did we set a new record for insurance in force, but it was a record year for life insurance sales, which totaled \$6.564 billion. And December 2007 was our best month ever, adding \$864.1 million of new life insurance coverage for our members and their families. Our insurance sales for December 2007 exceeded the amount sold during the entire year in 1978."

"I am very proud of our 1,300 field agents and 130 general agents, who worked so hard and so effectively to help Knights protect their families and build financial security," Anderson continued. "Our founder, Fr. Michael J. McGivney, believed strongly that we should provide every Catholic man with the means to protect his family from financial ruin by offering a sound, professionally-run life insurance program. The size and strength of our insurance program is a worthy testament to his far-sighted vision."

The Knights of Columbus is the world's largest lay Catholic organization, with more than 1.7 million members around the world. Last year, Knights donated more than 68 million hours of volunteer time and \$143 million to charity. It is currently celebrating the 125th anniversary of its founding in 1882.

As leaders in your Districts, what are your and your council's New Year's resolutions? As the new year approaches, there seems to always be some discussion and contemplation on New Year's resolutions. For just about everyone who does this, resolutions are the exercise of setting goals

for ourselves that might build upon something - maybe our own spiritual and personal growth? When we set these goals, we should be forward thinking and forward looking. What I mean by that is we make decisions on how we might want to change based upon where we want to go or what we want to be. It also helps that when we set these goals, we remember who we are and where we have come from. When setting resolutions, remember to set these goals or resolutions reflecting back on last year and the road we have traveled. By doing so, we might set reasonable, achievable and more satisfying goals.

This is a good time to look at the months left in the fraternal year and to set goals to get things done starting now. It's easy to wait until the last minute to realize what you wanted to happen - and it's hard to make what you want to happen during the last minute. So start now! Make it happen now when there is time to make things work!

REGIONAL MEETINGS - I wish you well during these meetings in January. They are important opportunities to help your councils connect with the State Council representatives and help prepare these last six months of the fraternal year. Encourage maximum attendance if possible. Provide feedback to our state leaders as to what works and what doesn't. They want to hear this!

FRATERNAL SURVEY - Get your Councils Fraternal Survey reports in NOW. They are due in January!

... AND MORE REPORTS - Plan to remind your councils of the Fraternal Audits which are due in February!

CLOSING THOUGHTS - I recently came across some Dakota Indian Tribal wisdom that I thought I might share. This relates to the best strategy to use when you discover you are riding a DEAD horse - the Dakotas DISMOUNT. How simple and effective this strategy is. How often do we adopt a different strategy when faced with the same situation? Here are a few of the best FAILED strategies that might put a smile on your face... Buy a bigger and stronger whip.

1. Change riders
2. Say things like, "This is the way we have always ridden this horse!"
3. Appoint a committee to study the horse.
4. Arrange to visit other sites to see how they ride dead horses.
5. Blame the horse's parents.
6. Harness several dead horses together for increased speed.
7. Create a training session to increase riding abilities.
8. Promote the dead horse to a supervisory position.

### Fr McGivney Guild Message



You may have heard or read Father McGivney being referred to as a Servant of God. This is the title that one receives when the results of the diocesan investigation are passed on to the Vatican's Congregation for the Causes of Saints. If the Congregation agrees with the findings, the pope proclaims that the person has lived a life of heroic virtue. With this comes the title venerable.

The next step is beatification. In order to be beatified, one miracle must be proved to have happened through the intercession of the candidate after his or her death (for a martyr, this miracle is not necessary). The miracle is thoroughly investigated and must be accompanied by the testimony by medical or scientific experts that the healing occurred in an immediate and lasting way and without any reasonable medical explanation. After beatification, a person has the title of blessed and can be venerated at the local level.

The final step is canonization, which can proceed after another miracle has been verified. These miracles are important because people can make mistakes in judgment about a person's holiness. A miracle is considered God's way of confirming the judgment.

After canonization, the person is called saint and belongs to the universal Church for veneration and as an example of Christian living.

Father McGivney's cause stands at an important moment. The process, as outlined by the norms of the Church, has been completed. Dominican Father Gabriel B. O'Donnell (director of the Father Michael J. McGivney Guild and postulator of Father McGivney's cause for canonization) has presented to the Holy See both the position for life and virtue and the position for a reported miracle. While we await the judgment of the Congregation, it is encouraging that the Vatican Secretary of State, Cardinal Bertone, recognized (at the August 2007 Supreme Convention in Nashville, TN), the impact that this cause will have on the life of the Church.

Let us continue to pray for Father McGivney to rapidly proceed from Servant of God, to venerable, to blessed, and, finally, to saint.

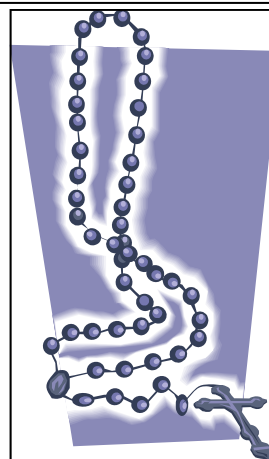
### APPEAL FOR FINANCIAL HELP FOR FLOOD VICTIMS IN WESTERN WASHINGTON

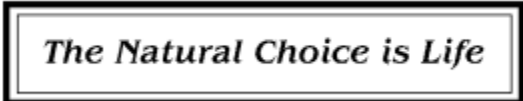

- The Icon is about 30 x 40 inches, and weighs about 15 pounds. It feels relatively light for its size.
- Printed on the bottom of the Icon is a greeting that was sent on behalf of our Holy Father.
- The Icon does not come with an easel. You will need to find a way to display it.
- There is a small cardboard box that comes with the Icon.
- The box contains a logbook, to record the date of your event and the number of participants. I understand that a summary of this information will be sent to our Holy Father at the end of the program.
- The box also contains a large number of copies of a booklet in-

tended to be used to lead a prayer service.

- The prayer service consists essentially of an opening and closing song, two readings, a homily, and a rosary, all of which is printed in the booklet.
- The booklets need to be returned to the box and passed along to the next Council.
- The first pages of the booklet provide a short history of Our Lady of Charity.
- The box also contains a large number of copies of a prayer card. These may be given out to those who attend the service, and they need not be returned.

### Family Message



Brother Knights,

I hope that you all had an excellent Holiday season with your families. The time is approaching when I will get a chance to visit with you at the Regional Meetings.

As always, the focus of my presentation will be on the preparation of outstanding State Family of The Year Write-ups (Due April 1 to me) and outstanding State Family Service Program Write-ups (Due April 15 to me). I will be handing out an example of a 'Weak' Family of the Year write-up and one that is 'Strong'.

I want to share with you a few of my ideas about write-ups and maybe they will help you along.

- 1) Remember it is an **Honor** to be chosen to do this write-up and you have a responsibility to do your best for the family you are recognizing
- 2) Be specific about the family's involvement. Include dates of participation. This leaves no doubt about the **EXTENT** of involvement.
- 3) Tell a story around the accomplishments of the family. Oftentimes we receive a list of accomplishments that look like a 'laundry-list' instead of reading about a family. As the writer, **you truly believe** that your family is the best, or you wouldn't be writing it. When you write a story about your family, your words will 'sell' your family, because your feelings will come out in the story. That is important!...the judges just want to see it the way you do... they want to believe in your family the way you do. Get them on-board!
- 4) Include pictures in your write-up. Nothing warms up the reader faster than to see the human beings that you are writing about. It allows the judges to imagine the family working together, doing what you said they did.
- 5) Back up your write-up by seeking letters of support from the people that have influence and know that your family is a winner and deserves the award. Parish priests, bishops, fellow Knights that have held high offices, are just a few examples of people to solicit letters of support from. Including these letters allows the judges to see the family from another author's perspective, as well as **VALIDATING** what you have already said.
- 6) Don't be afraid to draw parallels between your family's accomplishments and the scriptures. We are a Catholic Organization and our ideals come from scriptures. Showing how your family is following those ideals will further validate what a fine Catholic family you are writing up.
- 7) Take this task personally! Write it as though your reputation as a Knight of Columbus rides on your family winning the award. It will motivate you do the best that you can, it will allow you to write with intensity, and it will make you proud of your work when you are done. Not every write-up can win, but every write-up can be your best effort. Remember, there is a family on the other side of this write-up who has accomplished great things... you owe them your best.

### Message from Vocations, RSVP, PFH



The three-legged program of prayer, Pennies for Heaven and RSVP for vocations is working very well, thanks to the generosity of our Brother Knights around the state.

Indeed, Washington State Knights constitute less than one percent of the Order's membership, yet contribute an amazing four percent of all the RSVP monies collected throughout the Order.

Pennies for Heaven goals will be sent out to all Grand Knights, Financial Secretaries and District Deputies in early January in the same mailing as the state per-capita assessments.

We should once again easily surpass the goal of a penny a day – this year, the goal is just over \$54,000.

We have not yet achieved last year's record level of support for seminarians – a minimum of three Councils or Assemblies supporting seminarians for the Archdiocese of Seattle, and a minimum of two Councils or Assemblies supporting seminarians for the Dioceses of Spokane and Yakima. Indeed, we are still without any support for one seminarian for Yakima. All Grand Knights were advised in September of the current addresses for the seminarians that I expect they are supporting, as well as notification of seminarians who have either been ordained or dropped from the program. If your Council or Assembly can possibly support another seminarian, please let me know.

District Deputies received a list of Councils in their district and the names of the seminarians I believe the Councils to be providing support for through RSVP. Please verify the list with your District Deputy and notify me of any discrepancies.

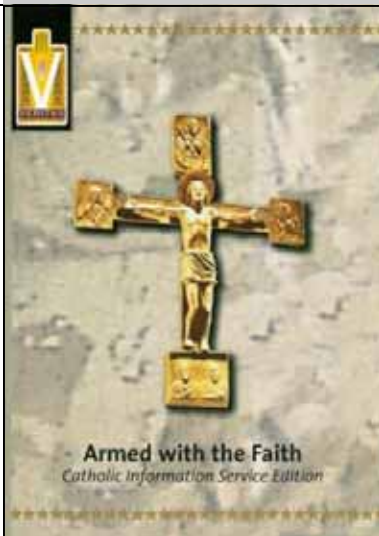
