Message from State Deputy John Walker

Worthy Brother Knights:

October is a critical month for all of us. It is our last chance to do that we can do to help defeat the "Assisted Suicide" initiative 1000 that will be voted on November 4th. Financial support is still needed to help the Catholic Campaign Against Assisted Suicide purchase much needed television and radio advertisement. Through September 26, approximately \$225,000 has been collected and sent to CCAAS to help defeat the initiative. Your help at the parish level in distributing flyers, collection envelops, helping with the video, and manning voter

registration tables is most appreciated. As of last week a King TV5 poll shows approximately 54% leaning toward passage. The numbers of undecided has moved from 11% to 17%, which means the word is getting out of the dangers of the initiative. We need to continue to work toward converting the undecided to our side by all the usual strategies – telephone calls, going door to door, placing signs in strategic places, standing on street corners with signs, registering voters, and collecting money. See the picture elsewhere in this bulletin of what one of our Brother Knights is doing. Supreme to date has matched \$125,000 with more on its way. Timing is of the essence as October 13 is the deadline for donations over \$5,000. On October 16 mail in ballots will be sent to voters. Please do not let up now. This initiative must be defeated to preserve our Culture of Life.

As I stated last year, where have all the members gone??? We started the year with 16,288 members and are now at 16,206 as of September 26. We have lost a net of 82 brothers to death, transfers and suspensions. To date 121 new brothers have joined the Order but 137 have been suspended. I understand the need to purge your council records on members and drop those that you cannot contact. As long as the procedures are followed and every effort is made by your council retention committee and the District Deputies to contact these men and the 1845's are sent to Retention Chairman Monte Cromwell, then so be it. Keep in mind, however, you are expected to try to replace the suspended members and meet your goals as set by Supreme. You have an opportunity during the October "Blitz" to reach out and embrace and bring great Catholic gentlemen, who want to be Knights, into the Knights of Columbus. I have supreme confidence and faith in all of you that you will accomplish your membership goals and reach the "Star Council" level.

According to Supreme records, there are 53 councils to September 26 who are membership active. That leaves 90 who are inactive. This number compares with 110 inactive at the same time last year. Below are those councils who are active to date. Congratulations to the following councils:

For those who have not had the opportunity to recruit new members, it would be nice if during the Blitz in October the number of inactive councils dropped to 50. Let's make it happen!!

There are only 4 councils who have failed to submit their Report of Officers Chosen (F185), 37 their Service Program Personnel Report (F365), and 39 their Semi-Annual Audit Reports. (See listings of

those delinquent elsewhere in this bulletin). I have instructed the District Deputies to take a form 185 or 365 to the respective councils who are delinquent and help them to complete the forms. We must have 100% reported. I solicit your cooperation in this matter. Thank you in advance.

During October, in addition to the "Blitz", remember to observe Columbus Day on October 13, Respect Life Sunday, October 12, and World Mission Sunday, October 19. October also brings us five 2nd and 3rd Degree Exemplifications. (Check the calendar for one in your area). I expect many 1st degree exemplifications during the month. The Spanish 1st Degree team is coming across the mountains to Kennewick Council 8179 for a Spanish 1st Degree on October 11. In addition to a large number of candidates, our Chaplain Bishop Sevilla from Yakima plans to be present. We also expect Bobby Velasquez, Hispanic Field Coordinator, from California to attend. This will be the first Hispanic degree to be held on the East side for many years.

Also in October, I will have the honor of presenting on your behalf from our Pennies for Heaven Fund, checks for \$30,000 each to Bishop Sevilla of the Yakima Diocese and to Bishop Skylstad of Spokane for seminarian support. The check to Archbishop Brunett of Seattle will be presented in December. The PFH Board of Directors also voted to give the Dominican Brothers \$1,500 to help with their seminarians.

In closing, even though I may post negative information on delinquent reports and inactivity, it is not meant to be critical but constructive. I recognize that Grand Knights are the backbone of councils, that you are the Chief Executive Officers, and without you as leaders your councils would not grow. I also recognize that all of you have lives outside the Knights of Columbus and the day is only so long. Continue to do what you do and be the strength of your councils. I am depending on each of you.

May God Bless each of you and your families as we all continue to do Gods work.


Tobit 8:1-21: A Story of Oneness by Fr. Wilmar O Zabala

I tell you the Book of Tobit is way better than the romance novels and daytime soap operas you ladies are reading and watching these days! Here's the synopsis: The angel Raphael disguises himself and accompanies Tobiah, son of Tobit, to the home of Sarah's father, Raguel. Tobiah falls in love with Sarah. Tobiah refuses to eat his dinner until he gets Raguel's permission to marry his daughter, Sarah. Tobiah says, "I will eat or drink nothing until you set aside what belongs to me." It sounds more like a demand to me! Raguel finally gives in and allows his daughter to marry Tobiah. But Raguel warns Tobiah that Sarah has been married seven times and all of her seven husbands have died, and interestingly enough, all of them died before they had sexual relations with her. Talk about scaring away your future son-in-law! But the main part

of the story isn't this part of falling in love and getting married. It's what happens in the bedroom. Tobiah gets his wife to pray with him. Tobiah could have easily prayed by himself – alone! But no, he invites Sarah to pray with him. For me, one of the ultimate measures or gauges of a truly great marriage is when spouses help each other develop a closer relationship with God. Also notice the content of their prayer. It's about appreciation they have for each other. Tobiah says, "Now, Lord, you know that I take this wife of mine not because of lust, but for a noble purpose. Call down your mercy on me and on her, and allow us to live together to a happy old age." Tobiah isn't praying for superiority, for his wife's more attentiveness to his needs, for his wife to agree with him on everything, for his wife to appreciate

him more. It's none of those. Instead, Tobiah is grateful to God for his wife's presence in his life.

There's one thing that they acknowledge in their prayer. They acknowledge this: "It's not good for the man to be alone." Did you know, by the way, that men drive more safely when their wives are in the car, and have fewer wrecks and speeding tickets? No, there's no such thing as a lone ranger.

When life gets challenging, when arguments and disagreements arise, what will ultimately help us handle these struggles is the tangible presence and company of another breathing human being, nothing else, not even shopping, not even golf, not even football, not even Budweiser beer. This another breathing human being doesn't have to be a girlfriend or a boyfriend. This another breathing human being doesn't have to be a person you're seriously involved with. This another breathing human being doesn't even have to be from the opposite sex. There's only one criterion given in the Scriptures: Oneness! The two shall become one flesh! Oneness is not just, and definitely more than, sexual intimacy or union between married couples; it's most importantly referring to our ability to give ourselves to another person in the mystery that our gospel reading calls love. Or in the words of one of my favorite young authors, Matthew Kelly, a true companion is someone who can help us become the-best-version-ofourselves. I really think that's what Tobiah did to Sarah in this short love story!

Fr McGivney Guild Message



As a continuation of a previous article on the process of sainthood, below are some historical items on "relics" that your friends might ask you about.

Once a decision for **beatification** is announced, the **postulator may supervise opening of the individual's tomb and take a portion of the individual's re-**

mains. This will be presented to the pope as a relic of the newly beatified during a pontifical Mass celebrating the beatification. At this time the pope will assign a date for the blessed's annual feast day.

What, exactly, are relics and what's their place in Catholic doctrine?

The word itself comes from the Latin for "remains" and, these days, relics fall into three categories.

- First class: A part of the body of a saint or blessed, or, as in the case of Father McGivney, of a candidate for sainthood. There are no first-class relics of Father McGivney.
- Second class: An item or piece of an item worn or used by a holy person during his or her lifetime a pair of sandals, rosary or pencil, for example. The Father McGivney Gallery at the Knights of Columbus Museum in New Haven displays the cassock in which Father McGivney was buried. When his remains were moved from the family plot in Waterbury, CT, to St. Mary's Church in 1982, the cassock was removed and restored, and his body was clothed in new vestments. A prayer card distributed by the Father McGivney Guild includes a small thread from Father McGivney's burial cassock.
- Third class: An item that has been touched to a first-class relic. Usually, a third-class relic is a bit of cloth.

How did veneration of relics get started?

Scripture scholars say there is no "cult of relics"— devotion shown to relics — in the Old Testament. Such items are mentioned in the New Testament, but are not given too much attention. (Acts 19:12)

Church historians say the writings about St. Polycarp (c. 69-155) show Christians in the city of Smyrna (in what is now Turkey) were the first to openly venerate the relics of a saint — their beloved Bishop Polycarp. On the anniversary of his death, members would gather at his grave and pray for his intercession.

This was a public and explicit form of devotion. The Christians in Smyrna let everyone know they had a particular attachment to the remains of their friend. And once they had done that, they needed to justify what they were doing. The community stressed the "subordinate character" of the veneration of martyrs. These holy men and women weren't on a par with Christ. And the respect shown to their relics didn't match — shouldn't match, couldn't match — that shown to God. Rather, St. Polycarp was honored because this holy person had been a disciple and imitator of Christ. In the middle of the third century, St. Cyprian of Carthage, a bishop, said venerating the instruments used to torture and kill the martyrs was an acceptable practice because their bodies had made those items holy. In the fourth century, St. Basil, a doctor

of the Church, wrote in detail about the official ceremonies held on an anniversary.

Over the next few hundred years, venerating martyrs' relics grew as a liturgical practice and theologians looked at what was happening and said it made sense. Tombs were opened and items were touched to the body or bones. Then these relics — called brandea — were distributed throughout the community. People kept brandea, the equivalent of today's third-class relics, in little cases hung around their necks.

What is Church teaching regarding relics?

The Second Vatican Council mentions relics in its Constitution on the Sacred Liturgy: "The saints have been traditionally honored in the Church and their authentic relics and images held in veneration."

The Catechism of the Catholic Church says, "besides sacramental liturgy and sacramentals, catechesis [teaching] must take into account the forms of piety and popular devotions among the faithful. The religious sense of the Christian people has always found expression in various forms of piety surrounding the Church's sacramental life, such as the veneration of relics, visits to sanctuaries, pilgrimages, processions, the Stations of the Cross, religious dances, the rosary, medals, etc."

Notes from the District Deputy Director Leadership Training, Coaching & Mentoring

At the Summer Leadership meeting, we discussed several important factors in being a successful District Deputy. The Keys to Being a Successful District Deputy was outlined in the training handbook – the

Red Book.

One of the keys emphasized was Leadership Training, Coaching and Mentoring. Successful District Deputies are continually helping develop leadership qualities and skills within their district. Developing leadership skills starts with developing one's own skill set. Given the opportunity, successful DD's will learn the basics of being a good leader. This first starts with becoming familiar with the requirements of the job while continuing "to learn the ropes" as it pertains to you job and your district.

Being a good leader and teaching leadership skills most always involves helping council officers and leaders in your district. Successful DD's mentor and coach their council leaders – they DO NOT direct them. The opportunity for mentoring and coaching may come through any number of challenges or situations facing council leaders. Without giving out answers or easy solutions to problems, successful DD's will listen, guide, coach and mentor council leaders to a solution that will become a learning experience for all of those involved.

Successful DD's are often in frequent communications with their grand knights. This comes though telephone communications, e-mails, or one-on-one discussions before or after a meeting. Successful DD's will emphasize positive strengths of their council leaders. Being a good leader always involves being a good listener.

A Check List – How are you doing?

As always, here are a few reminders for you for this month. How are you doing with these tasks?

□ District Warden

Have you appointed a District Warden for your District? If not, this is something that you might be soon considering. Review the key points about this that are outlined in the DD Training manual.

☐ Membership Blitz Reporting

DD are required to report to the Membership Chairman the activity of your councils Membership Blitz activity.. NOTE: This means whether or not your councils conducted a Blitz, you still need to report! Plan accordingly.

□ Mid-Year DD Meeting

If you haven't already got this added to your schedule, note that the Mid-year Meeting will be held December 6-7 in Renton. This meeting is an important working meeting for all the DD's followed by an evening of fun and fraternity. In advance

of this meeting, you should be prepared to talk about how your District is doing. Bring all of your issues and opportunities to the meeting so that these can be addressed and discussed. You will hear more about this in a letter from our State Deputy sometime this month. It is important to plan to attend.

☐ Shining Armor Award – Silver Knight Award

Are your councils using these two programs? If not – why not? These are two of the best programs to help get new members involved and to help keep seasoned members active. It also helps with recruiting. If you are not promoting this in your district – consider starting this.

□ Council Administrative Issues

Are your councils current with their responsibilities with respect to Per Capita, Insurance, Ceremonial Fund and other paper work? You might help your councils remember their commitments to these issues.

WHAT ARE YOU DOING TO HELP DEFEAT I-1000???

Below is a picture of Brother D. Albert Brookbank, Sr. of St. Nicholas Council 9238 in Gig Harbor with the sign he is using to let people know to vote NO on the "Assisted Suicide" Initiative 1000. He has been at different locations in Gig Harbor in a six day period along highway 16 between Tacoma Narrows Bridge and Port Orchard. He conservatively estimates 57,000 to 60,000 cars and trucks have viewed his sign. He had a total of 9 individuals who verbally attacked him with gutter language. About 20% of women smiled - only one older lady gave him thumbs down. Most men gave the "V" sign or an A-OK from their cars or honked. The important point is that over 60,000 people were exposed to his sign. Brother Albert is requesting that "all those who believe in Christ, pick up their sign and stand on the corners when they can for the next 30 days left to defeat I-1000". Brother Albert has dedicated the remaining days of the campaign to Mary our Mother and he believes that prayers to Mary will help us to succeed and spell defeat for the initiative once and for all. He also says - "Mary and her Knights, a team beyond compare - for human life in all of its stages"!!! How true it

New Regional Program Consultant Western States

In September, the Supreme Council Department of Fraternal Services announced that it has appointed and hired Past State Deputy Patrick Maloney as a Regional Program Con-

sultant (RPC). Pat will serve as RPC for eight states including Washington, California, Hawaii, Idaho, Montana, Nevada, Oregon and Utah. As an RPC, Pat will be working with and supporting the state councils, state officers and district deputies in areas of membership recruitment, retention, leadership training, and team building. He will also work with each of the assigned jurisdictions in NCD, Round Tables, council retention and reactivation. During the next several months, Pat will be working and training with several of the RPC's including Frank Pulice, who he will eventually replace when Frank retires. Frank, who is a PSD of California and former Supreme Council Board Member, is planning on retiring in June 2009 after serving approximately 15 years in this position and after being the most tenured member of this group.

Pat was elected as State Warden in 1997 after serving two years as District Deputy. He was elected State Deputy in 2003 after moving through the state office chairs. He most recently was working as District Deputy Director under State Deputy John Walker.

18-Year-Old Squires Ready for Knighthood

Each year, many young men in the Squires celebrate their 18th birthday and face the end of their time as a Squire. Since joining the Squires, these members have actively progressed through the levels of the Squire Advancement Program, from "Page" towards "Squire of the Body of Christ," by organizing and participating in activities in their four service categories: Home and Family; Squires and Knights; Community and Country; and Church. These activities, as well as their activities as Squires, have prepared them for the next step in their experience: eligibility for membership in the Knights of Columbus.

Message Recruitment Chairman



Congratulations! The results from the August Blitz are coming in and it looks like the councils that made a plan & stuck to it have added new members. August as we know is normally a slow month for recruiting but even in a slow month results can be positive if an effort is made.

This however is only the first quarter of the game. When teams are not playing well they often take a deep breath & go back to basics. Even councils who are ahead of the game can stay ahead of the game by reviewing & updating their recruitment plan to make sure that the goal of meeting or exceeding their quota is in place & on track.

The traditional Blitz month October is here & all councils should be pulling out all the stops so that this month will bring in enough new members for the council to make 100% of quota by December 31. Keeping this in mind let's review a few recruitment tips. Talk to your priest & get his permission to recruit in the church. He is the boss so get him on your side. Be visible in your efforts to recruit. Each event sponsored by a council where non members are present should have an information table set up so that what the Knights are about can be carefully explained. Have pamphlets on hand & give them out. Read the materials supplied by Supreme & in the State Bulletin & develop talking points. In other words be knowledgeable about the Knights & what we do. Working together as a team with another Knight helps when one Knight is at a loss for an answer. Carry a F100 in your pocket. It sounds hokey but you never know.....

Here is another point & perhaps the most important – get your candidate to a Degree as soon as practical. Do not wait. District Deputies! If you have candidates from different councils & no 1st Degree on the horizon them form a team from your councils & hold a District Degree. One of the biggest losses of candidates is not being able to get them to a Degree in a timely manner. Councils with 1st Degree Teams! You should plan on holding a 1st Degree every month. Grand Knights with 1st Degree Teams! Call other councils in your District to see if they have candidates ready.

There are for those who are interested some rewards for successful recruiting. Supreme has a Recruitment Reward Points Program. Points are given for each member recruited & can be redeemed for K of C merchandise. Grand Knights can win a jacket by obtaining 100% of quota by December 31. Councils win by being on their way to making Star Council. District Deputies win by achieving Star District. The State Deputy makes the Circle of Honor. Field agents win by being able to present Knights of Columbus Insurance products. Insurance is the updated version of making Fr. McGivney's dream come true that no Knight's family should go unprotected. By the way your Field Agent is a value resource for recruitment. He is not to be underrated as he has many resources to help both in recruiting & retention.


The status report shows credits as a negative (in parentheses) which sometimes occurs when your payment gets updated before I receive notification from the Supreme Council of a membership increase.

"Vote Pro-Life" radio ad begins airing nationwide today

Knights of Columbus spot features beating heart of 10 week old unborn child

New Haven, CT - September 23, 2008 -

A 30 second radio spot (http://www.kofc.org/un/eb/en/news/releases/detail/547945.html) encouraging people to "vote prolife" in the November elections begins running on radio stations around the United States today. It will continue to air until the November 4 election.

The ad features the sound of an unborn baby's heartbeat at 10 weeks, and the voice of a woman saying, "Listening to this makes me wonder - why would anyone question that her life has begun?" It concludes with the words, "Vote your heart. Vote Pro Life."

"The fact that the child whose heartbeat we hear is alive is simply a matter of science," Supreme Knight Carl A. Anderson said in announcing the beginning of the ad campaign. "We believe that it is vital that America's pro-life community make it clear that they will reserve their votes for candidates of either party who are committed to protecting life from conception to natural death." A similar ad is planned for broadcast in Canada, where general elections are set for October 14, 2008.

The Knights of Columbus is the world's largest lay Catholic organization, with more than 1.75 million members in North and Central America, Asia and Europe. Last year, Knights donated \$145 million and more than 68 million hours of volunteer time to charitable causes.

Dear Brother Knights,

Grand Knights and their chairmen are already supporting the Bishops of Washington State in their effort to defeat I-1000. The roadmap to supporting the Bishops is described in the mailing dated September 1, 2008, directing Grand Knights or his representative to make an appoint-

ment with his parish priest to help him educate parishioners on the errors of assisted suicide.

In the mailing, a DVD was included, and is intended to be shown at close of Masses or during the homily. Some council's are unsure about our parish's commitments to show either the Diocese or KC DVD's. Of course, the DVD can be shown at council meetings and can to be used as tool to educate all Knights also.

We suggest the following alternative to showing the DVD at Masses. Of course first clear this with your parish priest:

The Washington State Catholic Conference of Bishops has produced a brochure "#2 Assisted Suicide & I-1000". This brochure should be handed out at the close of Masses to all attending parishioners. Please note, for maximum visibility, do not insert the flyer in the bulletin. Have your brothers hand it directly to each parishioner. This brochure is available in both English and Spanish, so be sure and specify which is desired.

The easiest way to obtain this brochure in volume is to request an electronic copy and use as a master for printing locally. That way you can produce as many as you want, and save the postage and cost of your diocese. Just e-mail back to me and I will send the master to you. Your parish priest can also order printed copies, but this might take longer time.

We are in home stretch and we are winning, but much work remains. Some of you have asked about educating our community by going door to door and drop-leafing materials in your neighborhood. I recommend recruiting parishioners to help you in this activity. The Coalition Against Assisted Suicide has prepared a drop-leaf brochure that can be used for that purpose. If you need brochures for your neighborhood let me know. If you have recruited 10 volunteers, you will need at least 500 brochures, or 50 per volunteer.



If your council serves more than one parish, provide this announcement to brothers in your council who belong to the second or third parish, ask then to include this announcement in their parish bulletin. Please do this today.

I-1000 Assisted Suicide Troubling Issues in Oregon's Law

A study by doctors Herbert Hendin and Kathleen Foley, published in May 2008, analyzed the Oregon assisted suicide law over the past ten years. They found that the "safeguards" in the law were illusionary. One of the "safeguards" requires patients who request physician-assisted suicide be referred for the psychological or psychiatric evaluation if they seem to be experiencing depression or psychological problems.

The Oregon law is an example that what is supposed to work and very often does not work in real life. The first patient to die by assisted suicide in Oregon was diagnosed as depressed by her physician. Suicide advocates found a physician willing to prescribe a lethal overdose. The doctor who wrote the lethal prescription knew her for only two and a half weeks. Between 1998 and 2005, only 13% of those requesting physician-assisted suicide were referred for evaluation. In 2007, not one of the 49 people who died by physician assisted suicide was referred.

Say no to assisted suicide and say yes to help the weak and vulnerable.


Also, please all FS's save last month's bulletin article by the State Advocate on IRS form 990. It was a great article and we will all need it in a few months for next year's tax filings.

First Degree Team Ceremonial Competition Wayne C. Hogan, PSD, State Ceremonial Chairman



We are entering our third and final month of the first level of the First Degree Team Ceremonial Competition. This level is the district level and is conducted in August, September, and October.

Have the councils informed their district deputy that they want to participate in the competition? Have the district deputies encouraged their councils to participate

in the competition?

All councils in Washington are eligible and encouraged to participate in the First Degree Team Ceremonial Competition. If your council does not have a certified first degree team, your district deputy may certify it during the first level of competition. If your council has a certified First Degree team, however, there are still one or two members who need to be certified, your district deputy may certify them in conjunction with the first level competition. The council will normally schedule this evaluation during an actual exemplification

The first level is conducted during an actual exemplification in the council's regular meeting facility. An honoree should be selected for each degree. The honoree and all council knights are encouraged to attend the exemplification.

All grand knights are encouraged to contact their district deputy and schedule an evaluation of the council's first degree team. Remember, that under no circumstances will a 1st Level - District evaluation - be conducted after October 31. The second level competition will be conducted in November and December. Additional information on the second and third level competition will be published in subsequent state bulletins.

The Grand Knight's Handbook CD was issued to all grand knights at the Summer Leadership Meeting in Pasco. Also, on the CD were two handbooks. The first is the First Degree Team Ceremonial Competition, revised 07/01/06. This handbook provides information on the participation, prerequisites, schedule, evaluation, reports, notification and recognition. Appendix A is an overview of the three levels, District, Regional, and State. Appendix B is the Evaluation Form that will be used to evaluate the degree teams. The second is the Host and Co-Host District Deputy's Second and Third Degree Ceremonial Procedures, revised 07/01/08.

'The Best of the Best' First Degree Team Ceremonial Competition travel award will look great hanging in your council's hall. Where it is located next year depends on you!

therefore have an obligation in conscience to work toward correcting morally defective laws, lest they be guilty of cooperating in evil and in sinning against the common good" (United States Conference of Catholic Bishops [USCCB], Catholics in Political Life).

When morally flawed laws already exist, prudential judgment is needed to determine how to do what is possible to restore justice—even if partially or gradually—without ever abandoning a moral commitment to full protection for all human life from conception to natural death (see Pope John Paul II, Encyclical *Evangelium Vitae*, no. 73).

Prudential judgment is also needed to determine the best way to promote the common good in areas such as housing, health care, and immigration. When Church leaders make judgments about how to apply Catholic teaching to specific policies, this may not carry the same binding authority as universal moral principles but cannot be dismissed as one political opinion among others. These moral applications should inform the consciences and guide the actions of Catholics.

What Does the Church Say About Catholic Social Teaching in the Public Square?—Seven Key Themes

A consistent ethic of life should guide all Catholic engagement in political life. This Catholic ethic neither treats all issues as morally equivalent nor reduces Catholic teaching to one or two issues. It anchors the Catholic commitment to defend human life and other human rights, from conception until natural death, in the fundamental obligation to respect the dignity of every human being as a child of God.

Catholic voters should use Catholic teaching to examine candidates' positions on issues and should consider candidates' integrity, philosophy, and performance. It is important for all citizens "to see beyond party politics, to analyze campaign rhetoric critically, and to choose their political leaders according to principle, not party affiliation or mere self-interest" (USCCB, *Living the Gospel of Life*, no. 33). The following themes of Catholic social teaching provide a moral framework for decisions in public life.²

The Right to Life and the Dignity of the Human Person

Human life is sacred. Direct attacks on innocent human beings are never morally acceptable. Within our society, life is under direct attack from abortion, euthanasia, human cloning, and destruction of human embryos for research. These intrinsic evils must always be opposed. This teaching also compels us as Catholics to oppose genocide, torture, unjust war, and the use of the death penalty, as well as to pursue peace and help overcome poverty, racism, and other conditions that demean human life.

Call to Family, Community, and Participation

The family, based on marriage between a man and a woman, is the fundamental unit of society. This sanctuary for the creation and nurturing of children must not be redefined, undermined, or neglected. Supporting families should be a priority for economic and social policies. How our society is organized—in economics and politics, in law and public policy—affects the well-being of individuals and of society. Every person and association has a right and a duty to participate in shaping society to promote the well-being of individuals and the common good.

Rights and Responsibilities

Every human being has a right to life, the fundamental right that makes all other rights possible. Each of us has a right to religious freedom, which enables us to live and act in accord with our God-given dignity, as well as a right to access to those things required for human decency—food and shelter, education and employment, health care and housing. Corresponding to these rights are duties and responsibilities—to one another, to our families, and to the larger society.

Option for the Poor and Vulnerable

While the common good embraces all, those who are in greatest need deserve preferential concern. A moral test for society is how we treat the weakest among us—the unborn, those dealing with disabilities or terminal illness, the poor and marginalized.

Dignity of Work and the Rights of Workers

The economy must serve people, not the other way around. Economic justice calls for decent work at fair, living wages, opportunities for legal status for immigrant workers, and the opportunity for all people to work together for the common good through their work, ownership, enterprise, investment, participation in unions, and other forms of economic activity.

Solidarity

We are one human family, whatever our national, racial, ethnic, economic, and ideological differences. Our Catholic commitment to solidarity requires that we pursue justice, eliminate racism, end human trafficking, protect human rights, seek peace, and avoid the use of force except as a necessary last resort.

Caring for God's Creation

Care for the earth is a duty of our Catholic faith. We all are called to be careful stewards of God's creation and to ensure a safe and hospitable environment for vulnerable human beings now and in the future.

Conclusion

In light of Catholic teaching, as bishops we vigorously repeat our call for a renewed politics that focuses on moral principles, the defense of life, the needs of the weak, and the pursuit of the common good. This kind of political participation reflects the social teaching of our Church and the best traditions of our nation.

Open Letter to Senator Joseph Biden on abortion

Supreme Knight Carl Anderson sent an open letter (http://www.kofc.org/un/cmf/resources/SK_20080919.pdf) to Senator Joseph Biden on Friday, September 19, challenging the assertion of the vice presidential candidate that Catholic teaching on abortion is not clear. The letter was published in USA Today, The Washington Times, Philadelphia Inquirer and Wilmington News Journal, among others.

Writing "as a fellow Catholic layman," Anderson said that "statements that suggest that our Church has anything less than a

consistent teaching on abortion are not merely incorrect; they may lead Catholic women facing crisis pregnancies to misunderstand the moral gravity of an abortion decision."

Anderson noted that the founders of the United States "believed that we are 'endowed by [our] creator with certain unalienable rights," and that first among these is 'life," and he appealed to Biden, "as a Catholic who acknowledges that life begins at conception, to resolve to protect this unalienable right."
