Worthy State Deputy and dear Brother Wallace:

Both the U.S. House of Representatives and the U.S. Senate have now passed health care reform bills. Thanks to the efforts of Brother Knight Congressman Bart Stupak (D-MI), a broad bipartisan coalition of representatives was able to add language to the House version that maintains the long-standing policy against the federal funding of abortion. Unfortunately, the Senate version does not. It fails to maintain the policy against the federal funding of abortion and does not protect the conscience rights of those who refuse to participate in abortion. The U.S. bishops have called the Senate version "deficient" and have said that it should be opposed.

A joint House and Senate conference committee will soon meet to reconcile the difference between these two bills, and both chambers are expected to vote on a final common bill in January. It is crucial that every member of the House and Senate hear from us so that the final bill will not mandate federal funding of abortion and will adequately protect conscience rights.

I urge you to contact every Knight in your state and ask them to contact their elected representatives in both the House and the Senate. They can reach their elected representatives by email, phone calls or fax letters. Please go to the Knights of Columbus homepage at www.kofc.org for instructions on how to contact your Representative and Senators.

Brother Knights should also immediately call or visit the local office of their Representative and Senators while they are in their home districts during the Christmas recess.

Time is of the essence. Congress returns to Washington soon. We must prevent this health care legislation from becoming the largest expansion of abortion in our country since *Roe v. Wade*.

Message from State Deputy, John Wallace

Thank You From The State Deputy

When you hear the words, "I don't have time," from a prospective member, don't let this be a "discouraging word." We all hear this at times. During my recruiting efforts the answer I give is that it's okay to be what I call a "Silent Knight." We need both active and inactive Knights, and the reason is that **numbers count**. When politicians or any other groups understand the size of the Knights of Columbus, they pay attention. The Supreme Knight's "Culture of Life" is an example of the need to show the power of members backing him up when dealing with people and programs not in line with the Church and the Knights' beliefs. The new Knight might not be an active member in your council, but he is counted in the big picture.

Washington State is closing in on our goal of 17,000 members, at around 16,526 as I write this. I believe and trust that we can close this gap before June 30, 2010. I'm willing to try my best to achieve it.

I have the pleasure to announce that for the first six months of the fraternal year the Washington State Jurisdiction has gained 3 new councils. We are now at 148 councils strong and closing in on 150. Congratulations to Council 14852, St. Matthew's of Seattle, DD 26 Keith Klaus, DD 1 Romy Ablao & New Council Development Chairman Del Treichel. My congratulations also to Council 14922, Our Lady of Lourdes, Spokane, DD 18 Tom Sokol & New Council Development Chairman Dave Olson; and Council 14926, St. Joseph's of Sunnyside, DD 17 Ed Perez, & New Council Development Chairman Marcel Bergeron and Field Agent Armando Villarreal and his wife, Corina, who got the ball rolling at Sunnyside. Congratulations to all who worked on developing these new councils. I must also mention that other District Deputies and New



Council Development Chairmen are hard at work on developing other councils and round tables.

The next great news I would like to share is that membership in Washington State has met the halfway goal set by Supreme of 900 new members for the Fraternal Year. On Nov. 15, I sent a letter to all District Deputies and Grand Knights, stating that in order to meet this halfway point of 450 new members by 31 Dec, **200 more new members would be needed**. I asked you to "get it done" and you did. This requires a big thank you from me to all who work so hard for the Washington State Council.

My mother used to say about her sons, "There's not a lazy one in the bunch." I can say the same for all the District Deputies, Directors, Chairmen, Grand Knights, in fact, all Knights in Washington. All of you should realize how important you are to the Washington State success.

The State Deputy Road Show will have new topics in 2010, i.e. FS training; "what's wrong with my council and how do I fix it," and council officer training. Let me know what you would like in your area.

Archbishop Alexander Brunett, Bishop William Skylstad and Bishop Carlos Sevilla have written thank you letters to the Knights of Washington for the \$31,000 PFH checks they each received from you for seminary support, and for all that you do for the priests and seminarians.

It sure was an honor to present the State Deputy's 1000 Point Club Program, Supreme's new Food For Families Program and the Service Program Award information to the District Deputies at our Winter Meeting in Renton. I could not help but be impressed with the organizational skills and the dedication to duty that these men display. We are very lucky as a State to have such a fine group of men to lead our Councils on the local level. Way to go District Deputies...Keep up the good work!

If you read Supreme's new Food for Families Program above and you haven't heard of it yet, let me introduce it:

""Food For Families"" is a Supreme Council Program and it is part of their "Neighbors Helping Neighbors" Initiative that they started last February. What we need to do is to have at least 25% of our Councils (about 40) do a Food Drive & Restock of their local food bank. There is a form to fill out after the Food Drive is complete and this needs to be sent to me- I will be the State Chairman of this program. I will keep track of our progress. If we meet our goal, we will receive our portion of the \$1,000,000 that the Supreme Council has allocated for the food banks in this country. This program is a "SLAM DUNK"! I'll bet a lot of councils are doing this on a regular basis already, and think of how that money will be able to help out the poor in our communities. I will provide forms to the DD's for distribution and I will have them at all of the Regional Meetings held in January. If you need a form just e-mail me at StateWarden@kofc-wa.org and I'll send you one. I'll even include one in this bulletin. We want to help the hungry in our State and what a great way to do it!

As for my other favorite program, The State Deputy's 1000 Point Club, participation is still a little sluggish. Only 49 Councils turned in their forms for November so far. I will continue to hound you until you participate in this valuable program. If you want to catch up, now is the time to do it. District Deputy Director Message

The "Next Six Months" is the beginning of a crucial period for the jurisdiction of Washington, the Districts and more importantly the Councils. The main theme of the most recent Winter District Deputy Meeting held in Renton dealt directly with preparing for the "Next Six Months" and addressed such issues of importance as Membership, Recruitment, Retention, State Ceremonials and a myriad of other issues. Discussed also was the preparation by the state council for the State Convention to be held in Yakima, Washington in May 2010. The state councils responsibilities in preparing for this meeting and the importance of doing it now – preparing that is. One of my challenges to the District Deputies at the summer meeting was pre-planning. Pre-planning is now, starting to think about what the council is going to write about as to what have they accomplished this year in the way of "Surge with Service", what significant council activity in the service program area are they going to write about. Waiting till April 1, 2010 is to late, so preparing now and looking back at the past six months is a start. Using your 1000 Point Club monthly submission is a great place to start, but you know that already.

Now to the hard part, the District Deputies have been challenged with pre-planning and using communications as a tool to accomplish this. We took to long the last six months to complete Forms 185, 365 and audits (can u believe we still have two councils that haven't completed this report) and how many councils were interviewed for a Semi-Annual Visit on Form 944B. I know it is said, we as a council don't have to do reports or we will get them done when we want to get them done. Same old lazy attitude yet about 90% of the councils get them done within the time frame required and thank you for that. Seems like the same councils don't know and we waste to much valuable time but this is a time of positive thinking for the "Next Six Months" and we actually are on a very positive upswing.

Have you looked at what you have accomplished in November, very good numbers, very positive in not only Supreme areas but local jurisdiction. Active activity in the 1000 point club point to that, a slight activity in the Blitz and Recruitment activity, have you figured out the difference yet and how about the suspension of members area, all positive. However, with all the positives, the area that remains a mystery is the Insurance area. This area is one of the strongest that we have. How many other Fraternal Organizations can boast of those positive numbers, look at the Elks, Lions, Eagles and others all losing numbers and do they have nearly a fraction of the successful Insurance program we have? I ask you to become more aware of how the IRA program works, I ask you that you become as GK's, FS's and Trustee's more aware of the Form 100 and insure that each and every new candidate that becomes a member is aware of this great program and how it works. If you don't give them the chance to understand this program it will hurt them primarily but in the end will also hurt the council because without it or an insurance program you won't make Star Council or Star District. Have you also talked to those members who aren't insured about this great program. Get them on board and lastly get the insurance agents to your degrees and if they can't come let the State Deputy know so he can get an alternate agent to attend. It is important that we work hand in hand, going it alone will only result in disaster.

So as we approach the "Next Six Months", the time is now, the time for action is now not April 1, 2010. In November 1996 as I left the State Deputies meeting in Rye, New York a great Knights of Columbus member who worked for the Supreme Knight as an assistant, quickly hopped on the bus, said his goodbyes to all of us and gave us a parting shot – "if not you – who, if not now – when". This was said to all of the State Deputies on board that day and I was the State Secretary from Washington there that heard it. Anyone can use it but remember where it came from because it was original and please use his name if u r going to quote him - Harvey Barque, the original – in December of 1996 a little less than a month later, he had a massive heart attack and died.

PATH-FORWARD

As of December 1, 2009, we had **gained 332 new members** with **122 suspensions** for a **net gain of 210**.

The second half of the year is usually the most productive, so **we are “on pace” to achieve our “intake” goal of 900 new members and a “net” gain (after suspensions) of 650 members**. To do so, we will have to continue **to average over 81 new members each month and fewer than one suspension per council for the next six months**. With dues payments starting to be sent out, Financial Secretaries must be assisted so that members are not suspended for lack of payments.

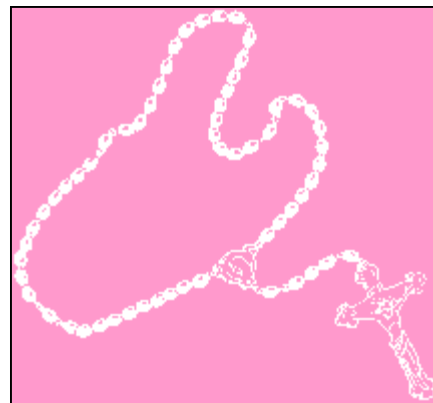
We still have **45 councils that are membership inactive**. If each of those councils brought in just two new members, the burden on the remaining 100 councils would be reduced to eight new members each. **Eighteen councils have net negative members** – I challenge them to recruit enough new members to return to a net zero balance for the year so that the other councils don’t have to make up for their 79 losses.

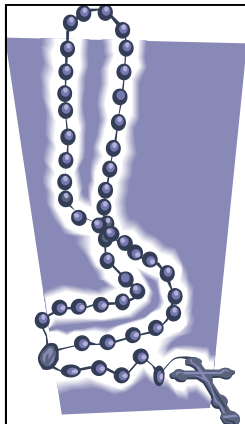

DISTRICT MASTER'S MESSAGE

"To defend and preserve"

Worthy Faithful Navigators, Faithful Comptrollers, Grand Knights, and Financial Secretaries:

The best way for councils to retain members is to get them into the fourth degree.

Our Fourth Degree membership for the Washington District on July 1, 2009 was 3,315. With 48 assemblies, Supreme has set a goal of a 10% gain by each assembly (i.e., 332 new members). At the November 14, 2009, exemplification in Bothell we brought in 43 new sir knights. Thus, with five more exemplifications remaining this year, we will need to bring in an average of 58 candidates per degree if we are to meet our goal.

The best way for us to gain new fourth degree members is to form new assemblies.

One assembly should be affiliated with one parish and one council. The advantage to this arrangement are clear:

- Dedicated Color Corps for parish and council events
- Reduced travel time to meetings and events
- More leadership opportunities
- Improved membership recruitment and retention

A new assembly can be formed when 30 council members are Sir Knights.

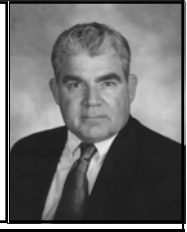
